Situated in the State of Ohio, County of Muskingum, Township of Clay, Township 14 Range 14, Section 10. Bounded and described as follows:

Being all of Max Toth Volume 737, page 52, Parcel No. 13-40-10-23-000 And Volume 1125, page 88 Parcel No. 13-40-10-21-000.

Beginning at a iron pin found at the Southeast Corner of Section 10; Thence **South 89° 53'37" West** along Harold Harney Volume 2039, page 544, **798.53'** feet to a iron pin found; Thence along Jack Brown Volume 1978, page 736 the next two courses and distances: **North 10° 42'18" West 542.59'** feet to a iron pin found, **North 57° 35'03" East 387.51'** feet to a point in center of County Road 87, passing a iron pin found at 350.04' feet; Thence continuing along Jack Brown Volume 1978, page 736 and along center of County Road 87 the next five Courses and distances: **North 02° 58'37" West 34.35'** feet to a point, **North 11° 39'41" East 48.45'** feet to a point, **North 19° 51'55" East 46.06'** feet to a point, **North 27° 24'39" East 47.21'** feet to a point and **North 29° 09'52" East 83.33'** feet to a point; Thence leaving said road and along James Swartz Volume 1611, page 668, **South 89° 55'43" East 475.32'** feet to a iron pin, passing a iron pin found at 27.17' feet; Thence **South 00° 38'12" East** along Kevin & Karen Rayl Volume 1833, page 781 and Ronald & Mildred Hall Volume 950, page 57, **978.61'** feet to the Place of Beginning, passing a iron pin set at 698.64' feet and the center of County Road 87 at 751.64' feet. Containing **16.75 Acres** total 15.48 Acres of Parcel No. 13-40-10-23-000 and 1.27 Acres of Parcel No. 13-40-10-21-000.

Bearings are based on the East line of Section 10, bearing North 00°38'12"West.



Bearings are based on the East line of Section 10, Bearing North 0°38'12" West. Bearings shown hereon are to an assumed meridian and are used to denote angles only


