Iron pins set are No. 5 reinf. bars 30" long with plastic I.D. caps.

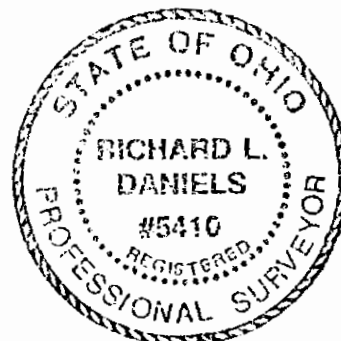

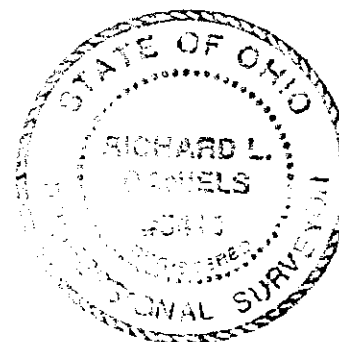

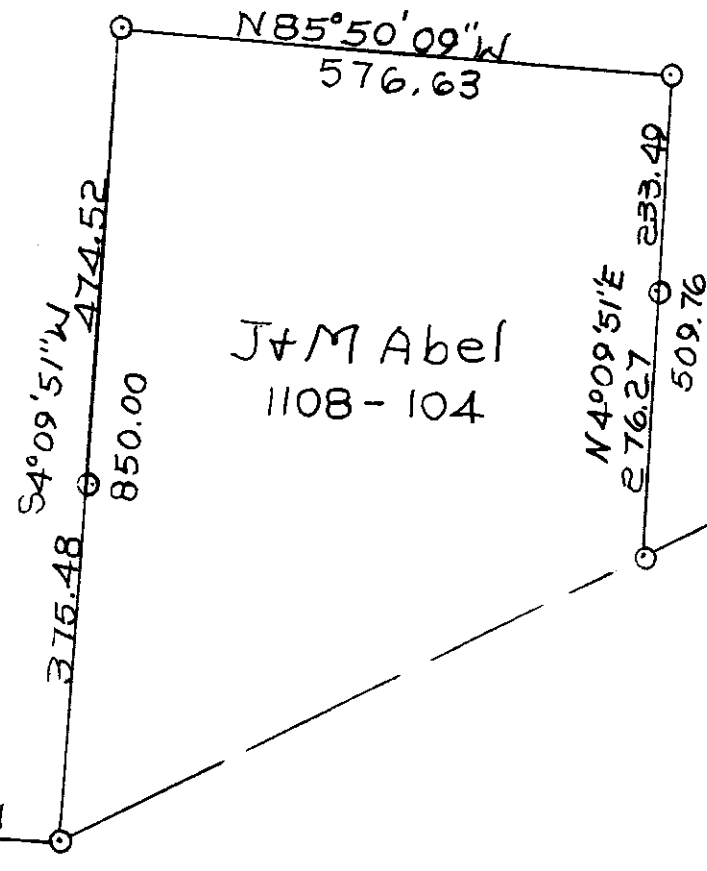
