Situated in the State of Ohio, County of Muskingum, Township of Clay, part being in the northeast quarter of Section 10 and part being in the west half of Section 11, Range 14 West, Township 14 North, of "The Congress Lands East of the Scioto River", and being bounded and described as follows:

Commencing for reference at a fence corner post at the northwest corner of Section 11 (Note: Reference bearing on the north line of the northwest quarter of Section 11 used as a grid bearing of South 85°49'40" East.);

thence, with the north line of Section 11, South 85°49'40" East a distance of 677.63 feet to a 5/8" iron pin set, being <u>THE TRUE POINT OF BEGINNING</u>, for this description;

thence, leaving the section line and passing through the lands of the grantor with a new division line, South 05°36'43" West a distance of 2,272.37 feet to a 5/8" iron pin found uncapped at the northeast corner of a 3.0 acres tract as conveyed to Jean Abel, et.al. by Book 2312, Page 174 of the Muskingum County Recorder's Office, passing through two 5/8" iron pins set at distances of plus 2,142.37 feet and plus 2,242.37 feet, respectively;

thence, with said Abel 3.0 acres tract, the following 3 courses:

- 1. South 89°59'19" West a distance of 543.59 feet to a 5/8" iron pin found uncapped;
- 2. thence South 00°00'41" East a distance of 240.40 feet to a 5/8" iron pin set near the run;
- 3. thence North 89°59'19" East a distance of 385.23 feet to a point in the center of Township Road No. 132 (Rider Road), passing through a 5/8" iron pin set at a distance of plus 335.23 feet;

thence, with the center of Township road No. 132, the following 8 courses:

- 1. South 19°53'50" West a distance of 85.56 feet to a point;
- 2. thence South 55°51'12" West a distance of 27.19 feet to a point;
