Parcel One:

Beginning at an iron pin found at the Southwest corner of the Southeast Quarter of Section 11; thence North $7^{\circ} 16' 28''$ East 1311.25 feet along Margaret M. Goins, Vol. 1043, Page 537, to a stone found; thence South $83^{\circ} 54' 09''$ East along M. A. Evans and William Hambrick Parcel Two 1825.46 feet to a steel marker found, passing an iron pin set at 1320.00 feet and 1802.46 feet; thence along the West line of E. & C. Pettit, Vol. 919, Page 57, the following three (3) courses and distances, South $13^{\circ} 24' 28''$ West 162.50 feet to a stone found, South $64^{\circ} 46' 24''$ West 202.74 feet to an iron pin set and South $6^{\circ} 33' 04''$ West 1046.41 feet to a stone found; thence along the South line of the Southeast Quarter of Section 11 North $83^{\circ} 50' 03''$ West 1650.24 feet to the place of beginning, containing 50.34 acres more or less.

Parcel Two:

Commencing at an iron pin at the Southwest corner of the Southeast Quarter of Section 11; thence North $7^{\circ} 16' 28''$ East 1311.25 feet to a stone; thence South $83^{\circ} 54' 09''$ East 1320.00 feet to an iron pin set, the place of beginning; thence North $7^{\circ} 16' 28''$ East 770.40 feet along M. A. Evans to a point in center of Rider Road, passing an iron pin set at 742.40 feet; thence along center of Rider Road and along A. & M. Hutson the following seven (7) courses and distances, South $58^{\circ} 58' 22''$ East 70.86 feet to a point, South $75^{\circ} 54' 28''$ East 134.55 feet to a point, South $64^{\circ} 34' 33''$ East 48.34 feet to a point, South $35^{\circ} 01' 13''$ East 68.21 feet to a point, from which an iron pin set bears North $59^{\circ} 31' 28''$ West 22.58 feet, South $11^{\circ} 58' 04''$ East 157.88 feet to a point, South $14^{\circ} 42' 04''$ East 317.88 feet to a point and South $19^{\circ} 06' 49''$ East 67.35 feet to a point; thence leaving Rider Road and along Guy Rider et al, Vol. 279, Page 400, the following two (2) courses and distances, South $4^{\circ} 15' 31''$ West 127.95 feet to an iron pin, passing an iron pin at 18.95 feet and South $47^{\circ} 23' 48''$ West 24.19 feet to an iron pin; thence North $83^{\circ} 54' 09''$ West 482.46 feet to the place of beginning, containing 6.63 acres more or less.

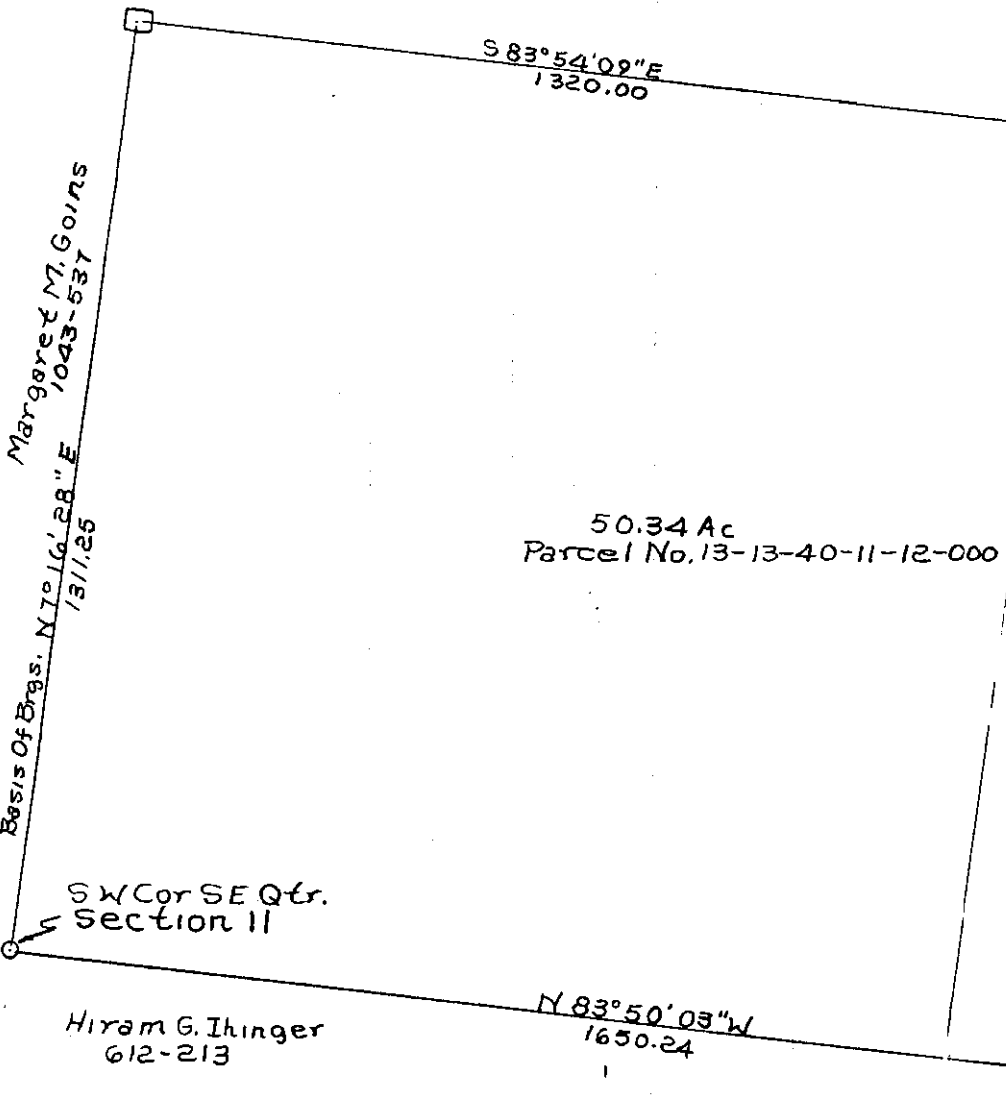
