SILER BY DEED VOLUME 570 PAGE 930 OF THE MUSKINGUM COUNTY DEED RECORDS; THENCE WEST 100.00 FEET ALONG SAID NORTH LINE TO AN EXISTING 5/8 INCH REBAR; THENCE NORTH 150.00 FEET TO AN EXISTING IRON PIN AT THE SOUTHWEST CORNER OF SAID LOT NUMBER 26; THENCE EAST 100.00 FEET ALONG THE SOUTH LINE OF LOT NUMBER 26 TO THE PLACE OF BEGINNING.
