COMMENCING AT AN EXISTING IRON PIN (5/8 INCH REBAR) AT THE NORTHEAST CORNER OF QUARTER TOWNSHIP 1;

THENCE WITH THE WEST LINE OF DEERWOODS SUBDIVISION SOUTH 02 DEGREES 52 MINUTES 28 SECONDS WEST 1267.59 FEET TO A POINT, PASSING EXISTING IRON PINS (5/8 INCH REBAR) AT 81.34 FEET AND 732.59 FEET;

THENCE NORTH 87 DEGREES 07 MINUTES 32 SECONDS WEST 300.00 FEET (ALONG THE LINE ESTABLISHED IN DEED VOLUME 1068, PAGE 463 OF THE MUSKINGUM COUNTY DEED RECORDS) TO AN EXISTING IRON PIN (5/8 INCH REBAR), SAID POINT BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED;

THENCE SOUTH 48 DEGREES 35 MINUTES 05 SECONDS EAST 106.66 FEET TO AN IRON PIN SET ON THE WESTERLY LINE OF DOCKRAY DRIVE;

THENCE WITH THE SAID WEST LINE OF DOCKRAY DRIVE ON A CURVE TO THE LEFT HAVING A RADIUS OF 250.00 FEET (CHORD BEARING SOUTH 26 DEGREES 32 MINUTES 24 SECONDS WEST 202.66 FEET) AN ARC DISTANCE OF 208.66 FEET TO AN IRON PIN SET;

THENCE CONTINUING WITH THE SAID WEST LINE, SOUTH 02 DEGREES 37 MINUTES 43 SECONDS WEST 85.20 FEET TO AN IRON PIN SET;




