

Re-Survey of part of Ray Thomas Lumbertown Inc. Lands, in Falls Township

Situated in the State of Ohio, County of Muskingum, Township of Falls, and being part of the Northwest Quarter of Quarter Township 2, Township 1, Range 8, United States Military Lands, and being part of the lands presently owned by Ray Thomas Lumbertown Inc. as per Deed Record 833, Page 323, and being more particularly described as follows:

Beginning for reference and the principal place of beginning at a stone found at the northeast corner of the Northwest Quarter of Quarter Township 2, Township 1, Range 8, United States Military Lands;

Thence along the west line of lands presently owned by Gary R. and Traci C. Lynn, Trustees, (OR 2244-21), South 02 degrees 55 minutes 42 seconds West, 456.08 feet to an iron pin found on the northeast corner of lands presently owned by Victoria Diane Lowe, (DR 1092-512);

Thence along the north line of said Lowe lands North 75 degrees 59 minutes 21 seconds West, 1494.07 feet to an iron pin found, on the northwest corner of said Lowe lands, passing iron pins found at 385.46 feet, and offline perpendicular north 0.47 feet, 592.34 feet, and offline perpendicular north 0.84 feet, 858.43 feet, and offline perpendicular north 0.56 feet, and 1075.35 feet, and perpendicular north 0.37 feet;

Thence along a west line of said Lowe lands, South 02 degrees 50 minutes 08 seconds West 1483.69 feet to an iron pin found on a north corner of said Lowe lands, passing iron pins found at 159.92 feet, and offline perpendicular west 0.39 feet, 573.89 feet, and offline perpendicular west 0.58 feet, 693.57 feet, and offline perpendicular west 0.55 feet, 823.85 feet, and offline perpendicular west 0.39 feet, 973.02 feet, and offline perpendicular west 0.50 feet, 1073.10 feet, and offline perpendicular east 0.30 feet, and 1287.99 feet, and offline perpendicular west 0.37 feet;

Thence along a north line of said Lowe lands, North 87 degrees 14 minutes 37 seconds West 660.22 feet to a point on the right of way of State Route 146, passing iron pins found at 299.92 feet, and offline perpendicular south 0.22 feet, 399.98 feet, and offline perpendicular south 0.21 feet, 590.82 feet, and offline perpendicular south 0.89 feet, and 636.59 feet;

Thence along said right of way, the following five courses:

- 1.) North 23 degrees 45 minutes 55 seconds West, 358.14 feet to point from which an iron pin set bears South 89 degrees 50 minutes 32 seconds East, 38.37 feet;
- 2.) North 29 degrees 06 minutes 55 seconds West, 360.00 feet to a point from which an iron pin set bears South 72 degrees 43 minutes 09 seconds East, 50.23 feet;
- 3.) North 33 degrees 25 minutes 55 seconds West, 458.00 feet to an iron pin set;
- 4.) North 28 degrees 57 minutes 05 seconds East, 49.00 feet to an iron pin set;
- 5.) North 08 degrees 22 minutes 10 seconds East, 65.00 feet to an iron pin set on the south line of lands presently owned by the U. S. A., (DR 496-458) and being on the 765 contour;

Thence along the meanders of the 765 contour the following four courses:

- 1.) North 44 degrees 12 minutes 58 seconds East, 223.77 feet to a G1 aluminum pin found;
- 2.) North 36 degrees 28 minutes 04 seconds East, 271.59 feet to a G1 aluminum pin found;
- 3.) North 53 degrees 04 minutes 49 seconds East, 260.13 feet to an aluminum monument found;
- 4.) North 00 degrees 01 minutes 01 seconds East, 6.13 feet to a point on the Falls\Muskingum Township Line;
