

Being a part of Quarter Township 2, Township 1, Range 8 bounded and described as follows:

Commencing at the northwest corner of Quarter Township 2, Township 1, Range 8; thence south 1 degree west 1666 feet to a point; thence south 86 degrees 59 minutes east 1424.60 feet to an iron pin and the true place of beginning of the premises herein intended to be described; thence south 84 degrees 45 minutes 55 seconds east 273.60 feet to an iron pin; thence south 83 degrees 30 minutes east 680.43 feet to an iron pin; thence south 60 degrees 39 minutes 57 seconds east 512.82 feet to a stone found; thence south 6 degrees 00 minutes 20 seconds west 1369 feet to a point in the center of old County Road #60; thence along the old centerline of said County Road #60 the following six (6) courses and distances; north 84 degrees 59 minutes 40 seconds west 400 feet to a point; thence north 84 degrees 29 minutes 40 seconds west 159 feet to a point; thence north 52 degrees 29 minutes 40 seconds west 152.60 feet to a point; thence north 38 degrees 14 minutes 40 seconds west 373.20 feet to a point; thence north 42 degrees 48 minutes 21 seconds west 330 feet to a point; thence north 35 degrees 11 minutes 10 seconds west 352.36 feet to a point; thence leaving said road north 6 degrees 23 minutes 06 seconds east 753.12 feet to the true place of beginning, containing forty-three and six hundredths (43.06) acres more or less.
