Commencing at the southeast corner of Deerwood Subdivision as recorded on Plat File 1, Page 123 in the Muskingum County Recorder's Office, thence South 84° 45' 55" East, 170.94 feet to a point at an existing iron pin at the southwest corner of a 19.16 acre parcel of D. Ousley (Deed Book 1043, Page 005), thence, South 83° 30' 00" East, 680.43 feet along the said D. Ousley to a point at an existing iron pin, thence, South 60° 39' 57" East, 512.82 feet along the said D. Ousley to a point at an existing stone at the northeast corner of a 43.06 acre parcel of D. Ousley (Deed Book 1043, Page 005) thence, South 06° 00' 20" West, 1166.12 feet along the east line of the said D. Ousley to an iron pin - found - thence, North 52° 22' 21" West, 519.63 feet along the north line of K. & R. Faulhaber (Deed Book 1125, Page 325) to the northwest corner of the said K. & R. Faulhaber, referenced by an existing iron pin at the point of beginning, thence, South 19° 32' 31" West, 497.52 feet along the west line of K. & R. Faulhaber (Deed Book 1125, Page 325) to a point at an existing iron pin in the center of County Road #60 as it existed before 1968, thence, North 52° 29' 40" West, 152.60 feet along the said centerline of County Road #60 to a point, thence, North 38° 14' 40" West, 28.09 feet along the said centerline to a point, thence, North 40° 44' 38" East, 467.10 feet across C. Ousley and M. McCune (Deed Book 1125, Page 322) to the point of beginning, passing an iron pin - set - at 101.84 feet.


