

Re-Survey of Judy E. Morgan\Cordell Lands

Parcel One

Situated in the State of Ohio, County of Muskingum, Township of Falls, and being part of the Northeast Quarter of Quarter Township Two, Township 1, Range 8, United States Military Lands, and being all the lands presently owned by Judy E. Morgan, also known as Judy E. Cordell, as per Deed Record 1018, Page 410, Parcel One, and being more particularly described as follows:

Beginning for reference at a stone found, (by deed), on the township line, at the Northwest Corner of the Northeast Quarter of Quarter Township 2, Township 1, Range 8, United States Military Lands;

Thence along the township line, South 87 degrees 40 minutes 30 seconds East, 1508.14 feet to an iron pin found, and the principal place of beginning;

Thence continuing along said township line, South 87 degrees 40 minutes 30 seconds East, 220.14 feet to a wooden corner post on the southeast corner of lands presently owned by Gary R. and Traci C. Lynn, Co-Trustees,(OR 2244-24);

Thence continuing along said township line, and the south line of Parcel Two, (to be described), South 87 degrees 40 minutes 30 seconds East, 199.05 feet to the centerline of Baughman Road, passing an iron pipe found at 174.45 feet;

Thence along the centerline of said road the following two courses:

- 1.) South 36 degrees 21 minutes 45 seconds East, 276.45 feet to a point;
- 2.) South 33 degrees 59 minutes 14 seconds East, 239.98 feet to a point on a corner of lands presently owned by Gary R. and Traci C. Lynn, Co-Trustees,(OR 2244-21);

Thence along the lines of said Lynn lands, the following three courses:

- 1.) South 26 degrees 33 minutes 53 seconds West, 135.04 feet to an iron pipe found, passing an iron pipe found at 21.45 feet;
- 2.) North 52 degrees 19 minutes 04 seconds West, 437.27 feet to an iron pipe found;
- 3.) North 46 degrees 44 minutes 43 seconds West, 426.27 feet to the principal place of beginning, containing 3.51 acres;

Morgan, also known as Judy E. Cordell, as per Deed Record 1018, Page 410, Parcel Two, and being more particularly described as follows:

Beginning for reference at a stone found, (by deed), on the township line, at the Northwest Corner of the Northeast Quarter of Quarter Township 2, Township 1, Range 8, United States

Military Lands;

Thence along the township line, South 87 degrees 40 minutes 30 seconds East, 1728.28 feet to a wooden corner post on the southeast corner of lands presently owned by Gary R. and Traci C. Lynn, Co-Trustees,(OR 2244-24), passing an iron pin found at 1508.14 feet, and being the principal place of beginning;

Thence along the east line of said Lynn lands, North 02 degrees 00 minutes 48 seconds East, 214.13 feet to an iron pipe found on the southwest corner of lands presently owned by Thomas L. and Melissa W. Bixler,(DR 562-120);

Thence along the south line of said Bixler lands, North 85 degrees 32 minutes 32 seconds East, 23.17 feet to a point in the centerline of Baughman Road;

Thence along the centerline of said road the following three courses:

- 1.) Along a non-tangent curve to the left having a radius of 216.74 feet and an arc length of 113.11 feet, a central angle of 29 degrees 54 minutes 03 seconds, and a chord which bears South 28 degrees 22 minutes 47 seconds East, 111.83 feet to a point;
- 2.) South 43 degrees 15 minutes 50 seconds East, 152.25 feet to a point;
- 3.) South 36 degrees 21 minutes 45 seconds East, 18.15 feet to a point on the Muskingum\Falls township line;

Thence along said township line, North 87 degrees 40 minutes 30 seconds West, 199.05 feet to the principal place of beginning, passing an iron pipe found at 24.60 feet, containing 0.49 acres more or less.


