SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, TOWNSHIP OF FALLS, AND BEING PART OF QUARTER TOWNSHIP 2, TOWNSHIP 1, RANGE 8, AND BEING ALL THOSE LANDS INTENDED TO BE DESCRIBED IN DEED VOLUME 794, PAGE 112, AND DEED VOLUME 990, PAGES 398, 410, AND 422; BEING FURTHER BOUNDED AND DESCRIBED AS FOLLOWS:

COMMENCING AT THE SOUTHEAST CORNER OF QUARTER TOWNSHIP 2, THENCE, ALONG THE SOUTH LINE THEREOF, NORTH 87 DEGREES - 50 MINUTES - 00 SECONDS WEST, 3870 FEET TO A POINT; THENCE, NORTH 01 DEGREES - 15 MINUTES - 00 SECONDS EAST, 300.32 FEET TO THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED; THENCE, CONTINUING NORTH 01 DEGREES - 15 MINUTES - 00 SECONDS EAST, 655.40 FEET TO A POINT IN TOWNSHIP ROAD #148; THENCE, SOUTH 87 DEGREES - 50 MINUTES - 00 SECONDS EAST, 319.20 FEET TO A POINT; THENCE, SOUTH 01 DEGREES - 15 MINUTES - 00 SECONDS WEST, 655.40 FEET TO AN IRON PIN, PASSING IRON PINS AT 20.00 FEET, 163.85 FEET, 327.70 FEET, AND 491.55 FEET; THENCE, NORTH 87 DEGREES - 50 MINUTES - 00 SECONDS WEST, 319.20 FEET TO THE POINT OF BEGINNING, PASSING AN IRON PIN AT 289.20 FEET, AND CONTAINING 4.802 ACRES MORE OR LESS.

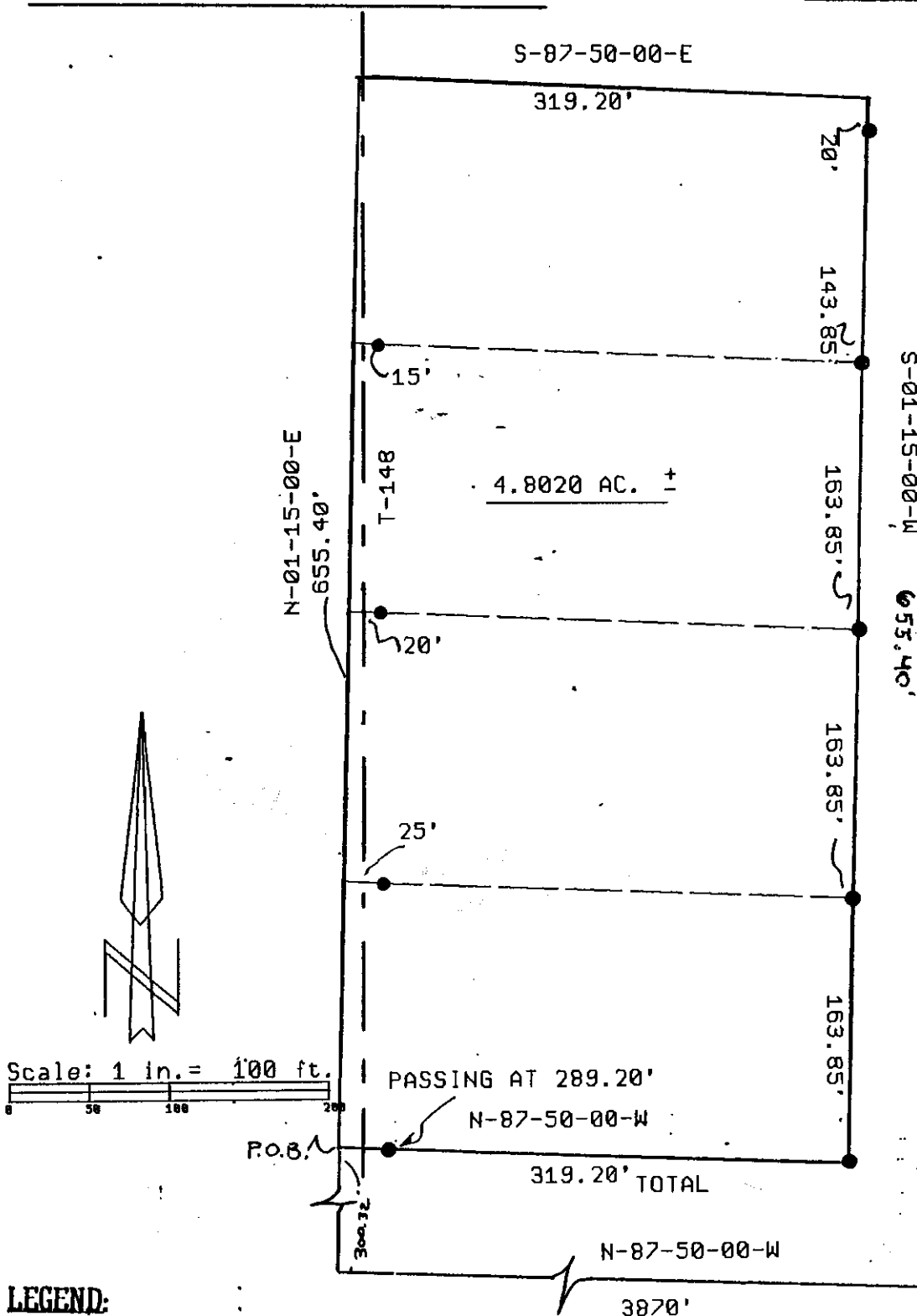

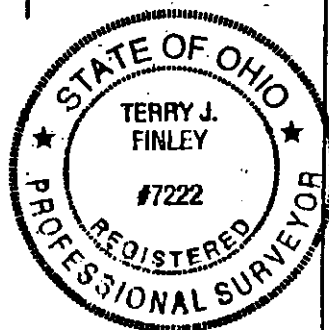
