## WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS:

That Ruth J. Henery  
hereinafter referred to as the Grantor (as used herein, Grantor includes the plural and words in the masculine include the feminine) in consideration of the sum of \_\_\_\_\_ Dollars (\$ \_\_\_\_\_ ) to him paid by the State of Ohio, the Grantee, the receipt whereof is hereby acknowledged, does hereby grant, bargain, sell and convey to the said Grantee, its successors and assigns forever, the following described real estate:

The lands herein described are situated in Bank Lot Number \_\_\_\_\_ Township \_\_\_\_\_, Range 8W, Falls Township, Muskingum County, State of Ohio. Being further described as follows:

PARCEL NO. 7WD

Being a parcel of land lying on the right side of the centerline of survey for Mus-60-22.70 made by the Ohio Department of Transportation, and recorded in Plat File \_\_\_\_\_, Slot \_\_\_\_\_, of the Muskingum County Plat Records and being located within the following described points in the boundary thereof.

Beginning at a railroad spike set where the east line of Bank Lot 6 intersects the center of existing State Route 60, at Station 1192+74.32 as shown on the plan of Mus-60-22.70 as mentioned above:

thence, **N45°29'23"W** a distance of **773.96 feet**, along the existing centerline of State Route 60 to a P.K. Nail set, located 0.50 feet left of centerline station 1200+48.27 of proposed State Route 60;

thence, on a curve to the right a distance of 293.81 feet, with a radius of 603.11 feet and whose chord bears **N31°32'01"W** a distance of **290.91 feet**, along the existing centerline of State Route 60 to a P.K. Nail set on the southwest corner of Donald N. and Anita Jane Melhorn's (830/114) 0.410 acre tract located 11.90 feet left of and radially to centerline station 1203+38.82 of proposed State Route 60;

thence, on a curve to the right a distance of 137.54 feet, with a radius of 603.11 feet and whose chord bears **N11°02'41"W** a distance of **137.24 feet**, along the existing centerline of State Route 60 to a P.K. Nail set, located 14.55 feet left of centerline station 1204+74.34 of proposed State Route 60;

thence, **N04°30'42"W** a distance of **171.15 feet**, along existing State Route 60 to a point located 6.44 feet left of centerline station 1206+45.30 of proposed State Route 60;

thence, on a curve to the left a distance of 251.14 feet, with a radius of 5729.58 feet and whose chord bears **N05°46'02"W** a distance of **251.12 feet**, along the existing centerline of State Route 60 to a point located 0.04 feet left of and radially to centerline station 1208+96.33 of proposed State Route 60;

thence, on a curve to the left a distance of 20.53 feet, with a radius of 5729.58 feet and whose chord bears **N07°07'33"W** a distance of **20.53 feet**, along the existing centerline of State Route 60 to a point located 0.00 feet left of centerline station 1209+16.86 of proposed State Route 60;

thence, **N07°13'42"W** a distance of **85.55 feet**, to a point, located 0.00 feet left of centerline station 1210+02.42 of proposed State Route 60; being the **TRUE POINT OF BEGINNING**;

thence, **N07°13'42"W** a distance of **310.73 feet**, along the centerline of State Route 60 to a point, located 0.00 feet right of centerline station 1213+07.06 of proposed State Route 60;

thence, **S87°39'16"E** a distance of **40.56 feet** along the northern property line of Ruth J. Henery (729/257) to a set rebar, located 40.00 feet right of centerline station 1213+00.32 of proposed State Route 60;

thence, **S07°13'42"E** a distance of **310.78 feet**, along a new division line to a set rebar, located 40.00 feet right of centerline station 1209+95.62 of proposed State Route 60;

thence, **N87°35'24"W** a distance of **40.57** to a point, being the **TRUE POINT OF BEGINNING**;

It is understood that the parcel of land described covers 0.285 acres, more or less, including the present road which occupies 0.210 acres, more or less, and is a part of the Auditors Parcel No. 17-06-01-02-000. All set iron pins are 5/8" x 30" rebars with yellow I.D. caps inscribed "O.D.O.T. District 5". Bearings are based upon an assumed meridian.

Said stations being the Station numbers as stipulated in the hereinbefore mentioned survey and as shown by plans on file in the Ohio Department of Transportation, Columbus Ohio.
