thence; along the east line of Gerald L. & Joyce S. Appleman, Deed Book 1093, Page 599, North 00 degrees 11 minutes 14 seconds West 502.03 feet to an iron pin found,

thence; along the east line of Daniel L. & Cheryl L. Sylvester, Deed Book 2113, Page 525, North 00 degrees 08 minutes 26 seconds West 159.88 feet to an iron pin found,

thence; along the south line of Patrick W. & Bethany M. Renaud, Deed Book 2317, Page 865, North 89 degrees 49 minutes 04 seconds East 507.44 feet to an iron pin found in the west right-of-way line of Tranquility Lane,

thence; along the west right-of-way line of Tranquility Lane, along a curve to the left having a radius of 384.98 feet, and a chord bearing South 37 degrees 24 minutes 53 seconds East, a chord distance of 40.58 feet to a point,

thence; continuing along the west right-of-way line of Tranquility Lane, South 40 degrees 26 minutes 08 seconds East, 48.36 feet to a point,

thence; continuing along the west right-of-way line of Tranquility Lane, along a curve to the right having a radius of 75.00 feet, and a chord bearing South 07 degrees 35 minutes 45 seconds East, a chord distance of 81.35 feet to a point,

thence; continuing along the west right-of-way line of Tranquility Lane, South 25 degrees 14 minutes 46 seconds West, 268.28 feet to a point,

thence; continuing along the west right-of-way line of Tranquility Lane, along a curve to the left having a radius of 225.00 feet, and a chord bearing South 12 degrees 01 minutes 22 seconds West, a chord distance of 102.93 feet to a point,

thence; continuing along the west right-of-way line of Tranquility Lane, South 01 degrees 11 minutes 59 seconds East, 170.67 feet to an iron pin found,

thence; along the north line of Angela L. Jones, Deed Book 2001, Page 807, North 89 degrees 59 minutes 11 seconds West 439.89 feet to the true point of beginning, containing 7.52 acres, more or less.

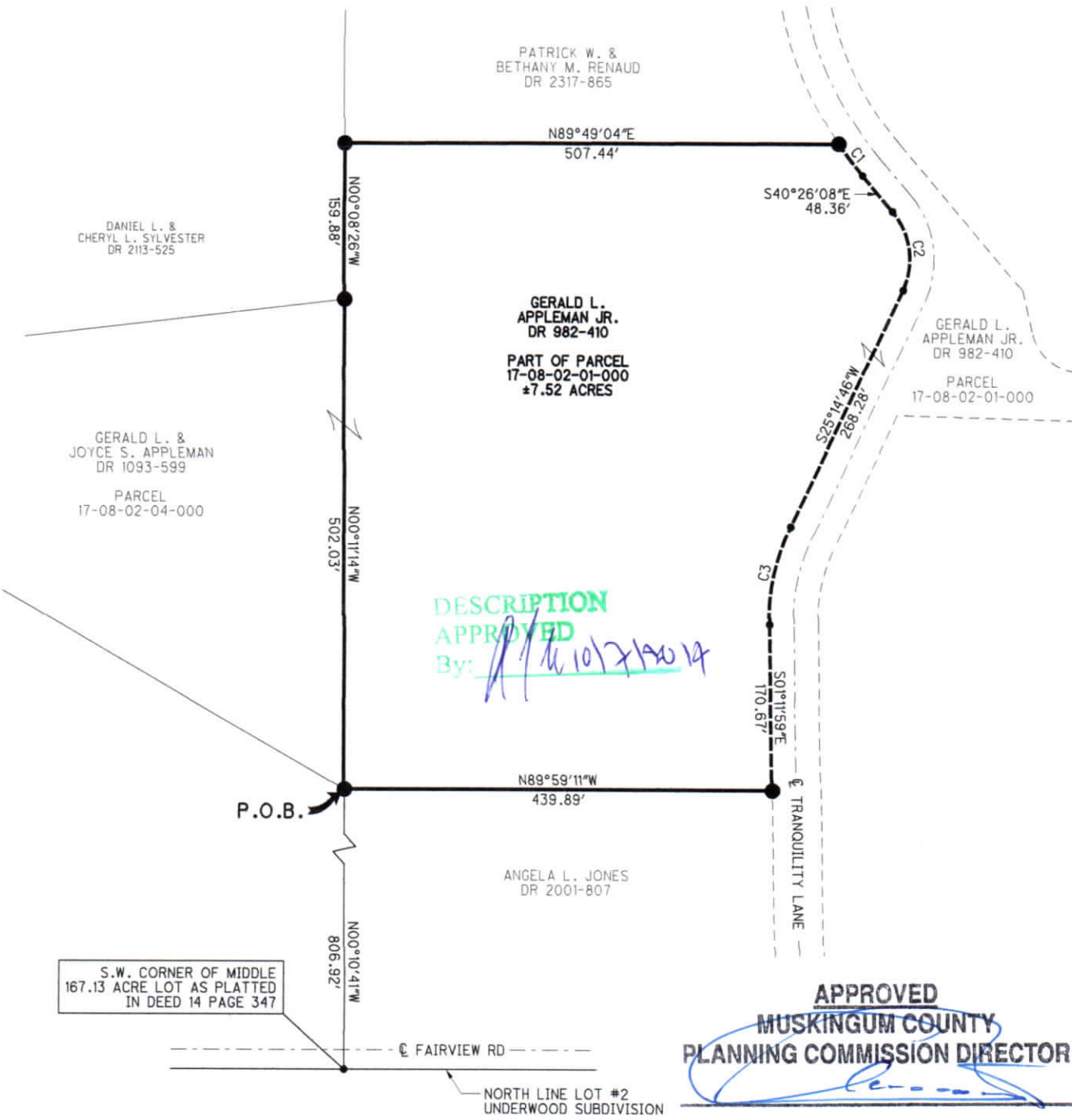

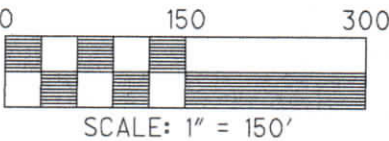
