Situated in the State of Ohio, County of Muskingum, Township of Falls, Township 1 N, Range 7 W, Quarter Township 2, being part of the west 167.13 Acre lot as platted in Deed Book 14, Page 347 and being further described as follows.  
Commencing at a point at the southeast corner of the west 167.13 acre lot as platted in Deed Book 14, Page 347, thence, North 00° 10' 57" West, 806.81 feet along the east line of the said 167.13 acre lot to the point of beginning at an existing iron pin at the northwest corner of R. Jones and A. Moore (Deed Book 1876, Page 613), passing existing iron pins at 348.71 feet and 466.88 feet,  
thence, North 59° 56' 47" West, 613.74 feet across G. & J. Appleman and M. & L. Lones (Deed Book 1093, Page 599) to a point on the east line of D. Little (Deed Book 1130, Page 464) at an iron pin - set,  
thence, North 30° 03' 13" East, 623.92 feet along the east line of the said D. Little to a point at an existing iron pin on the south line of D. & C. Sylvester (Deed Book 1161, Page 271),  
thence, South 67° 03' 08" East, 234.94 feet along the south line of the said D. & C. Sylvester to a point at an existing iron pin on the east line of the said 167.13 acre lot,  
thence, South 00° 10' 57" East, 755.81 feet along the east line of the said 167.13 acre lot to the point of beginning.




