1.11 Acres
Part of Parcel #17-17-15-01-15-000

Situated in the State of Ohio, County of Muskingum, Township of Falls.

Being a part of Bank Lot 18 in Quarter Township 1, Township 1, Range 8 bounded and described as follows:

Commencing at an iron pin found at the northwest corner of Lot 45 in Military Gardens No. 2 as recorded in Plat Book 8, Page 43; thence north 9 degrees 23 minutes 30 seconds east 263.55 feet to an iron pin; thence north 10 degrees 10 minutes 21 seconds west 73.98 feet to an iron pin; thence north 38 degrees 07 minutes 19 seconds west 82.40 feet to an iron pin; thence north 27 degrees 03 minutes 42 seconds west 98.85 feet to an iron pin; thence north 4 degrees 27 minutes 23 seconds east 647.2 feet to an iron pin; thence north 22 degrees 04 minutes 53 seconds east 52.80 feet to an iron pin and the true place of beginning of the premises herein intended to be described; thence continuing north 22 degrees 04 minutes 53 seconds east 30.20 feet to an iron pin; thence on a curve to the left having a radius of 50 feet an arc length of 83.68 feet (the chord of which bears north 34 degrees 08 minutes east 74.25 feet) to an iron pin; thence north 45 degrees 55 minutes 44 seconds east 351.08 feet to an iron pin; thence south 4 degrees 16 minutes 16 seconds west 317.32 feet to an iron pin; thence south 86 degrees 30 minutes 19 seconds west 282.15 feet to the true place of beginning, containing one and eleven hundredths (1.11) acres more or less.

There is also conveyed herein an easement for ingress and egress to be used by the Grantee and others over a strip of ground 50 feet wide along the entire west lines of the above described 1.11 acres and in a southerly direction to its intersection with Corvus Drive.




