(TRACT 2) Beginning at a railroad spike found where the East Line of the Eighth Range and Richey Road (Twp. Rd. 147) intersect; thence along Richey Road North 89 Degrees 51 Minutes 16 Seconds West 653.99 feet to a point and the place of beginning; thence continuing along said road North 89 Degrees 51 Minutes 16 Seconds West 235.10 feet to a point in said road; thence leaving said road North 00 Degrees 14 Minutes 18 Seconds East 472.09 feet to an iron pin found, passing an iron pin found at 25.00 feet; thence South 77 Degrees 29 Minutes 52 Seconds East 240.59 feet to a railroad spike set in a tree stump; thence South 00 Degrees 14 Minutes 17 Seconds West 420.61 feet to the place of beginning, passing an iron pin set at 390.61 feet, containing 3.06 acres, more or less, subject to all legal highways and easements.



