**THENCE** SOUTH 00 DEGREES 01 MINUTES 16 SECONDS WEST 10.31 FEET TO AN EXISTING IRON PIN (3/4 INCH PIPE);

**THENCE** WITH THE NORTH LINE OF SAID SKYLINE II NORTH 89 DEGREES 57 MINUTES 39 SECONDS WEST 345.29 FEET TO AN IRON PIN SET, SAID POINT BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED, PASSING AN EXISTING IRON PIN (3/4 INCH PIPE) AT 150.15 FEET;

**THENCE** CONTINUING WITH THE SAID NORTH LINE, THE NEXT FIVE COURSES AND DISTANCES:


