DESCRIPTION FOR CONVEYANCE

BEING A PART OF THE TRACT CONVEYED TO E. AND E. REIGLE AS RECORDED IN DEED BOOK VOLUME 521 PAGE 950 OF THE MUSKINGUM COUNTY DEED RECORDS; SITUATED IN THE 1ST QUARTER OF TOWNSHIP 1, RANGE 8, OF THE UNITED STATES MILITARY LANDS, FALLS TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

COMMENCING AT A POINT MARKED BY AN EXISTING IRON PIN (AXLE) AT THE SOUTHWEST CORNER OF LOT NUMBER SEVEN OF MEADOWBROOK SUBDIVISION AS RECORDED IN PLAT BOOK 8 PAGE 47 OF THE MUSKINGUM COUNTY PLAT RECORDS; THENCE NORTH 03 DEGREES 45 MINUTES 00 SECONDS EAST 114.80 FEET ALONG THE WEST LINE OF SAID LOT NUMBER SEVEN, AND THE EAST LINE OF THE ABOVE MENTIONED REIGLE TRACT TO A POINT MARKED BY AN IRON PIN SET (5/8 INCH REBAR), SAID POINT BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE CONVEYED; THENCE NORTH 74 DEGREES 20 MINUTES 16 SECONDS WEST 117.79 FEET TO A POINT MARKED BY AN IRON PIN SET (5/8 INCH REBAR); THENCE NORTH 43 DEGREES 42 MINUTES 57 SECONDS WEST 140.00 FEET TO A POINT ON THE WESTERLY LINE OF THE SAID REIGLE TRACT, PASSING A POINT MARKED BY AN IRON PIN SET (5/8 INCH REBAR) AT 130.00 FEET; THENCE NORTH 46 DEGREES 49 MINUTES 00 SECONDS EAST 172.00 FEET ALONG THE WESTERLY LINE OF THE REIGLE TRACT TO A POINT; THENCE SOUTH 89 DEGREES 13 MINUTES 00 SECONDS EAST 101.10 FEET ALONG THE NORTHERLY LINE OF THE SAID REIGLE TRACT TO A POINT IN TOWNSHIP ROAD 147 (RICHEY ROAD); THENCE SOUTH 03 DEGREES 45 MINUTES 00 SECONDS WEST 249.84 FEET ALONG THE EAST LINE OF THE SAID REIGLE TRACT (THE WEST LINE OF LOT NUMBER 4 AND LOT NUMBER SEVEN OF MEADOWBROOK SUBDIVISION) TO THE PLACE OF BEGINNING, PASSING A POINT MARKED BY AN EXISTING IRON PIN (AXLE) AT 20.00 FEET AT THE NORTHWEST CORNER OF LOT NUMBER 4 OF MEADOWBROOK SUBDIVISION






- ~ Existing Iron Pin (Axle)

Being a part of the first Quarter of Township 1, Range 8, U.S.M.L. Falls Township, Muskingum County, Ohio.


