1845 Aspen Drive

Situated in the State of Ohio, County of Muskingum, Township of Falls.

Being a part of Quarter Township 1, Township 1, Range 8 bounded and described as follows:

Beginning at an iron pin at the southwest corner of Lot 14 in Greenbriar Estates II Subdivision as recorded in Plat Book 15, Page 143; thence along the southerly line of said Lot 14 north 65 degrees 40 minutes 21 seconds east 162.20 feet to an iron pin; thence south 84 degrees 24 minutes 32 seconds east 130 feet to an iron pin; thence south 11 degrees 20 minutes 35 seconds east 173.93 feet to an iron pin; thence south 69 degrees 00 minutes 48 seconds west 219.11 feet to an iron pin on the east line of Aspen Drive; thence along the east line of Aspen Drive on a curve to the left having a radius of 1318.64 feet an arc distance of 112 feet (the chord of which bears north 27 degrees 31 minutes 19 seconds west 111.97 feet) to an iron pin; thence continuing along said Aspen Drive north 29 degrees 57 minutes 19 seconds west 110.29 feet to the place of beginning, containing one and twenty-three hundredths (1.23) acres more or less.


