Situated in the County of Muskingum, in the State of Ohio, and in the Township of Falls, more particularly described as follows:

Being the premises described in Muskingum County Deed Vol. 1088, Page 485, part of Bank Lot 10 in the First Quarter of Township 1, Range 8, as delineated in Deed Book K, Page 644 bounded and described as follows;

Beginning for reference at an axle found at the Northwest corner of lot #56 of Military Gardens #2, PB 8, page 43;  
thence along the South line of Corvus Drive North 87 deg. 35 min. 00 sec. West 195.23 feet to an iron pin found, being the principal place of beginning;  
thence South 02 deg. 17 min. 16 sec. West 220.00 feet to an iron pipe found;  
thence North 87 deg. 35 min. 00 sec. West 92.58 feet to an iron pin set;  
thence North 02 deg. 17 min. 16 sec. East 220.00 feet to a point;  
thence South 87 deg. 35 min. 00 sec. East 92.58 feet to the place of beginning (passing an iron pin set at 10.00 feet) and containing 0.47 acres, more or less.

Iron pins set are one half inch rebar, 30 inches long with yellow ID cap stamped DAVIS # 7972;

Subject to all legal right of ways, easements, restrictions, zoning regulations either written or implied and any pertinent facts disclosed from a full and accurate title search including railroad easements and right-of-ways.

The bearings for this survey are for angle calculations only and are based on the South line of Corvus Drive being North 87 deg. 35 min. 00 sec. West.




# PLAT OF SURVEY FOR JAMES E. LUCAS AND RUTH L. HAHN


