Commencing at the northwest corner of said Bank Lot 1; thence south 85 degrees 53 minutes 58 seconds east 1632.20 feet to an iron pin and the true place of beginning of the premises herein intended to be described; thence south 85 degrees 53 minutes 58 seconds east 443.86 feet to an iron pin; thence south 4 degrees 30 minutes west 1233.38 feet to an iron pin; thence north 85 degrees 10 minutes 39 seconds west 118.53 feet to an iron pin at the southeast corner of Outlot 1 of Nob Hill # 2 as recorded in Plat Book 11, Page 4; thence north 3 degrees 30 minutes 48 seconds east 200.53 feet to an iron pin at the northeast corner of said Outlot 1; thence along the northerly line of said Outlot 1 north 62 degrees 47 minutes 54 seconds west 335.60 feet to an iron pin; thence north 3 degrees 43 minutes 07 seconds east 899.68 feet to the true place of beginning, containing ten and forty-three hundredths (10.43) acres more or less.
