Being situated in Falls Township, Muskingum County, Ohio; and being Lot 5, Lot 6, and part of Lot 7 of "HOMEACRES" Allotment of record in Plat Book 7 Page 10; also being composed of those lands conveyed to the Grantors as follows: All of Deed Volume 648 Page 255, part of Deed Volume 588 Page 290, and part of Deed Volume 607 Page 214; the subject tract being more particularly described as follows:

Beginning at an iron pipe found at the northeast corner of the said Lot 5;

Thence along the easterly line of Lots 5, 6, and 7, South $29^{\circ} 37' 00''$ East a distance of 150.00 feet to an iron pipe set;

Thence along a line parallel to the northerly line of Lot 7, South $60^{\circ} 19' 55''$ West a distance of 250.00 feet to a railroad spike set in the westerly line of Lot 7;

Thence along the westerly line of Lots 7, 6, and 5, also being the easterly line of Maple Avenue (State Route 60), North $29^{\circ} 37' 00''$ West a distance of 150.00 feet to a point at the northwest corner of Lot 5;

Thence along the northerly line of Lot 5, also being the southerly line of Grove Road, North $60^{\circ} 19' 55''$ East a distance of 250.00 feet, passing over an iron pipe set at 5.00 feet, to the place of beginning, containing 0.861 acres as geometrically described herein; of which 0.373 acres is contained in Lot 5, 0.373 acres is contained in Lot 6, and 0.115 acres is contained in Lot 7; the above 0.861 acres also being divided as follows: 0.746 acres from Deed Volume 648 Page 255, 0.0805 acres from Deed Volume 588 Page 290, and 0.0345 acres from Deed Volume 607 Page 214.




