

## DESCRIPTION OF SURVEY FOR RACHEL A. WORSTALL

Situated in the State of Ohio, County of Muskingum, Township of Falls:

Being all of the Parcel #1, Parcel #2, & Parcel #3, of Tract #1, of the prior deed reference Volume 710, Page 234, of said county's deed records, also being all of Muskingum County Auditor's Parcel Number 17-17-38-03-25-000, 17-17-38-03-26-000, & 17-17-38-03-27-000, future being Part of Lot #158, All of Lot #159, and Part of Lot #160 of Blairmont No. 3 as recorded in Plat Book 7, Page 52, and Re-surveyed and recorded in Deed Book Volume 420, Page 628, and more particularly described as follows;

- Beginning at an iron pin (set) at the common Western corner for said Lots #158 and #159;
- #1- thence along the East line of Winding Way and the West line of said Lot #158 N 56 52 00 E 10.00 feet to an axle (found) at a corner of Parcel #3 Tract #1 of said prior deed reference
  - #2- thence through said Lot #158 and along the Northern line of said Parcel #3 S 45 07 00 E 208.05 feet to an axle (found) at a corner of said Parcel #3 and on the South line of said Lot #158;
  - #3- thence along the South line of said Lot #158 N 85 08 15 W 12.17 feet to an axle (found) at the common Eastern corner for said Lots #158 and #159;
  - #4- thence along the South line of said Lot #159 N 85 26 48 W 113.81 feet to an axle (found) at a common corner for said Lots #159 and #160;
  - #5- thence through said Lot #160 and along the South line of said Parcel #2 Tract #1 of said prior deed reference N 84 54 31 W 120.26 feet to an axle (found) at the PC of a curve on the East line of said Winding Way also being the West line of said Lot #160;
  - #6- thence along the East line of Winding Way, the West line of Lot #160, and with a curve to the right having, a Radius of 135.22 feet, an Arc length of 25.00 feet, and a Chord bearing N 10 07 33 E 24.96 feet to an iron pin (set) at a common corner for said Lots #159 and #160;
  - #7- thence continuing along the East line of Winding Way and the West line of Lot #159 with a curve to the right having, a Radius of 135.22 feet, an Arc length of 98.13 feet, and a Chord bearing N 36 12 47 E 95.99 feet to an iron pin (set) at the PC of said curve;
  - #8- thence continuing along the East line of Winding Way and the West line of said Lot #159 N 56 52 00 E 34.00 feet to the place of beginning containing 1794 square feet within Lot #158, 15495 square feet within Lot #159, and 1505 feet within Lot #160 for a total of 18,794 square feet or 0.431 acres.

The bearings within this description are based on the East line of Winding Way along Re-surveyed Lot #158 as shown in Deed Book 420, Page 628. Bearings are in a format of Degrees, Minutes, and Seconds. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness R.S.6885).

This description was written by Charles R.
