

Situated in the State of Ohio, County of Muskingum, Township of Falls:

Being part of Lot 24A of a Subdivision of Lot 24 Willow Lakes, recorded in Plat Book 8, Page 1B, further **being part of** the E Jeannie Young property recorded in Official Record Volume 2110, Page 887 of said county's deed records, further **being part of** Muskingum County Auditor's **Parcel Number 17-39-02-26-000**, and more particularly described as follows;

- Beginning at an iron pipe (found) at the common Northern corner for said Lot 24A and for Lot 23 of Willow Lakes Addition recorded in Plat Book 8, Page 3A;
- #1- **THENCE South 02 degrees 23 minutes 45 seconds West 20.00 feet** along said Lots 24A and 23 to an iron pipe (found) at the Northeast corner of Lot 24B of said subdivision of Lot 24;
 - #2- **THENCE South 71 degrees 43 minutes 55 second West 188.87 feet** along the common line for said Lots 24A and 24B to an iron pin (set);
 - #3- **THENCE North 08 degrees 38 minutes 10 seconds West 94.37 feet** crossing said Lot 24A to an axle (found) at an angle point on the North lines of said Lot 24 and subdivisions;
 - #4- **THENCE South 85 degrees 50 minutes 50 seconds East 194.87 feet** along the North line of said Lot 24A and subdivisions to the place of beginning, **containing 0.25 acres.**

The bearings within this description are based on State Plane Coordinate Grid (Ohio South 1983) derived from GPS Observations. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).




