Commencing at the southwest corner of lot 11 in John Sebaugh and recorded in plat book 9, page 45 of the deed records of said county, thence north 85 degrees 12 minutes west a distance of 268.68 to the true place of beginning for the parcel herein intended to be described; thence south 04 degrees 48 minutes 31 seconds west along the westerly line of lands now or formerly owned by M. and D. Lemert and recorded in deed book 701, page 200 of the deed records of said county, a distance of 470.34 feet to an iron pin; thence north 85 degrees 12 minutes west along the right of way line of Military Road a distance of 126.15 feet to an iron pin; thence north 07 degrees 58 minutes east along the easterly line of lands now or formerly owned by J. and C. Kappes and recorded in deed book 979, page 439 of the deed records of said county a distance of 116.93 feet to an iron pin; thence north 33 degrees 07 minutes east along said east line a distance of 74.65 feet to an iron pin; thence north 05 degrees 49 minutes 30 seconds east along said easterly line a distance of 94.50 feet to an iron pin; thence north 04 degrees 48 minutes east along said easterly line a distance of 193.39 feet to an iron pin; thence south 85 degrees 12 minutes east a distance of 82.66 feet to the true place of beginning, containing One and Three (1.03) hundredths acres more or less.

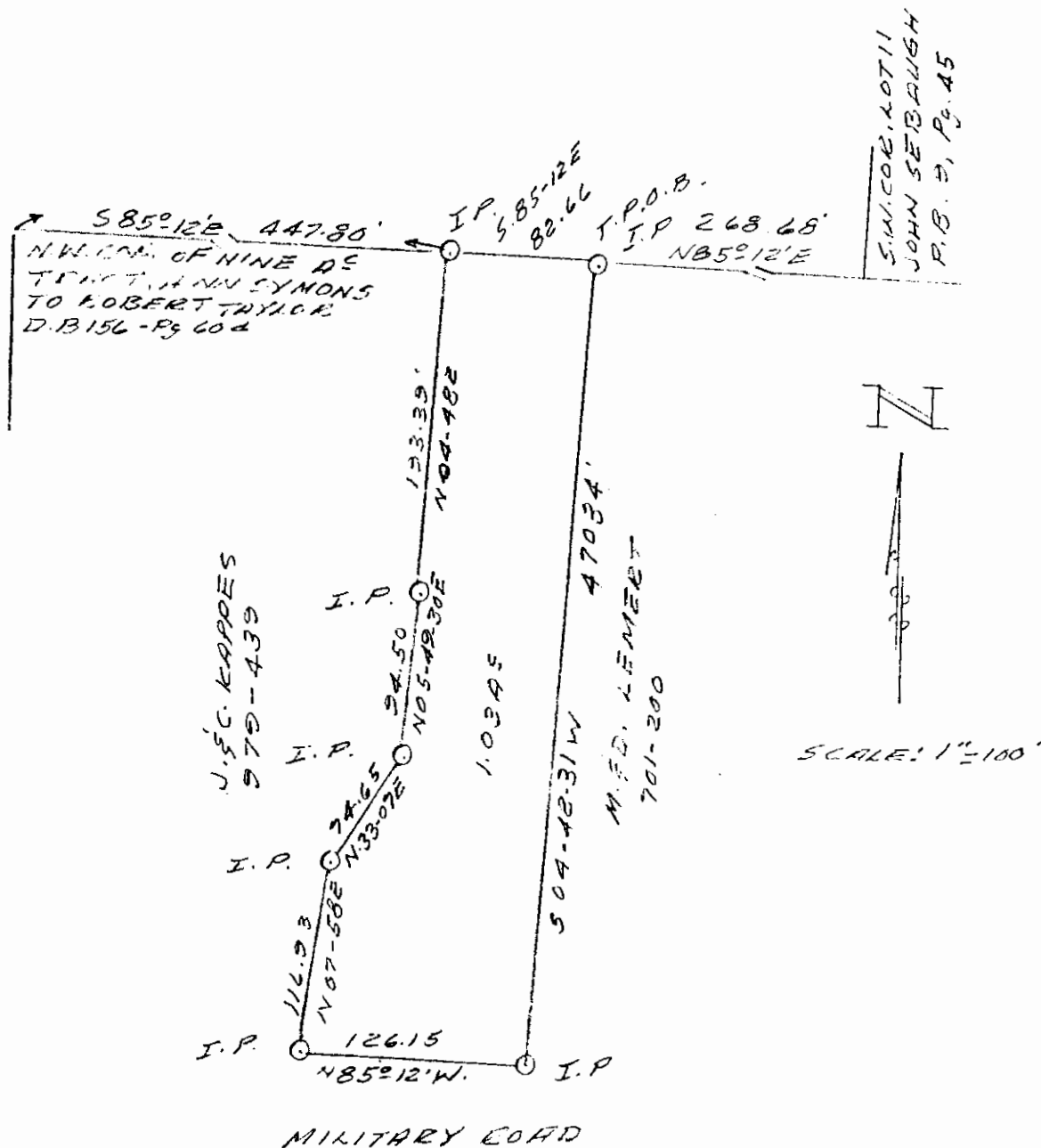
