Commencing at an iron pipe found at the southwest corner of Lot 11 of John Sebaughs Subdivision as Recorded in Plat Book 9, Page 45 of the Muskingum County Plat Records; thence north 87 degrees 15 minutes 39 seconds west (the base of bearings for this description true north by sun hour angle) a distance of 242.80 feet to an iron pin set at the true place of beginning for the following described parcel; thence south 2 degrees 19 minutes 18 seconds west 486.40 feet to a point in Military Road and passing an iron pin found at 469.66 feet; thence north 87 degrees 15 minutes 39 seconds west 90.85 feet to a point in said road; thence north 2 degrees 24 minutes 36 seconds east along property owned by F. Hall (Vol. 920, Pg. 239) a distance of 486.40 feet to an iron pipe found and passing an iron pipe found at 16.17 feet; thence south 87 degrees 15 minutes 39 seconds east 90.10 feet to the true place of beginning containing one and one hundredth (1.01) acres more or less.

Subject to the easements and right of way of Military Road and all legal right of ways of record.


