**COMMENCING AT A POINT AT THE NORTHWEST CORNER OF QUARTER TOWNSHIP 3;**

**THENCE WITH THE NORTH LINE OF QUARTER TOWNSHIP 3, SOUTH 88 DEGREES 02 MINUTES 40 SECONDS EAST 3583.53 FEET TO A POINT AT THE NORTHEAST CORNER OF A TRACT CONVEYED TO G. SHUEY et al. (VOLUME 969, PAGE 15);**

**THENCE LEAVING THE NORTH LINE OF QUARTER TOWNSHIP 3 AND WITH THE EAST LINE OF SAID SHUEY TRACT AND THE EAST LINE OF A TRACT CONVEYED TO W. HILL (VOLUME 1071, PAGE 294), SOUTH 02 DEGREES 10 MINUTES 20 SECONDS WEST 2407.92 FEET TO AN IRON PIN SET, SAID IRON PIN BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED;**

**THENCE LEAVING THE EAST LINE OF SAID HILL TRACT AND TRAVERSING THROUGH A TRACT CONVEYED TO JASON GOFF (VOLUME 1784, PAGE 841) THE FOLLOWING SIX COURSES AND DISTANCES;**

- 1) SOUTH 87 DEGREES 49 MINUTES 40 SECONDS EAST 357.28 FEET TO AN IRON PIN SET;
- 2) SOUTH 02 DEGREES 10 MINUTES 20 SECONDS WEST 160.83 FEET TO AN IRON PIN SET;
- 3) WITH A CURVE TO THE RIGHT HAVING A RADIUS OF 320.00 FEET (CHORD BEARING SOUTH 09 DEGREES 56 MINUTES 25 SECONDS WEST 86.50 FEET) AND AN ARC LENGTH OF 86.77 FEET TO AN IRON PIN SET;
- 4) SOUTH 17 DEGREES 42 MINUTES 30 SECONDS WEST 150.42 FEET TO AN IRON PIN SET;
- 5) WITH A CURVE TO THE RIGHT HAVING A RADIUS OF 25.00 FEET (CHORD BEARING SOUTH 67 DEGREES 30 MINUTES 00 SECONDS WEST 38.19 FEET) AND AN ARC LENGTH OF 43.45 FEET TO AN IRON PIN SET;
- 6) SOUTH 27 DEGREES 17 MINUTES 31 SECONDS WEST 20.00 FEET TO A POINT IN THE CENTER OF COUNTY ROAD 35 (PINECREST DRIVE);

**THENCE WITH THE CENTER OF COUNTY ROAD 35 (PINECREST DRIVE) AND WITH A CURVE TO THE LEFT HAVING A RADIUS OF 1680.00 FEET (CHORD BEARING NORTH 66 DEGREES 03 MINUTES 06 SECONDS WEST 195.98 FEET) AND AN ARC LENGTH OF 196.09 FEET TO A POINT;**

**THENCE CONTINUING WITH THE CENTER OF COUNTY ROAD 35 (PINECREST DRIVE), NORTH 69 DEGREES 23 MINUTES 40 SECONDS WEST 84.45 FEET TO A POINT;**


