

Commencing at an iron pin found at the Southwest Corner of said Lot 13; thence south 84 degrees 32 minutes 07 seconds east 175.44 feet to an iron pin and the true place of beginning of the premises herein intended to be described; thence north 10 degrees 32 minutes 59 seconds east 614.17 feet to a point in Pinecrest Drive; thence along the center of Pinecrest Drive the following four (4) courses and distances south 69 degrees 04 minutes 16 seconds east 136.63 feet to a point; thence south 79 degrees 04 minutes 36 seconds east 88.27 feet to a point; thence south 73 degrees 55 minutes 34 seconds east 193.25 feet to a point; thence south 51 degrees 36 minutes 37 seconds east 44.94 feet to a point; thence leaving said centerline south 41 degrees 38 minutes 30 seconds west 628.0 feet to an iron pin found; thence north 84 degrees 32 minutes 07 seconds west 130.96 feet to the true place of beginning, containing four and two hundredths (4.02) acres more or less.

Subject to the easements of Pinecrest Drive.
