SURVEY DESCRIPTION
FOR
DOROTHA WOLLANGUR

Situated in Quarter Township #3, T-1-N, R-8-W, U.S.M.L., Falls Township, Muskingum County, Ohio. Being the lands of Dorotha Wollangur as conveyed in Deed Book 686 page 108 of the Muskingum County Deed records and being more particularly described as follows:

Commencing at the Southeast corner of lot #7 of Monroe Duncan Subdivision ("P" /519); thence, N.01°00'00"E. a distance of 360.46 feet along the East line of said lot to the Northwest corner C. & B. Vousden (543/258); thence, S.89°00'00"E. a distance of 2,027.26 feet along the North line of said Vousden lands to a set iron pipe, BEING THE POINT OF BEGINNING; thence, S.01°13'56"E. a distance of 452.30 feet along said Vousden lands to a set iron pipe; thence, S.02°56'04"W. a distance of 247.70 feet along said Vousden lands to a set iron pipe; thence, N.89°41'04"E. a distance of 251.00 feet along said Vousden lands to a point in the center of County Road #144 (Dillon Falls Road), passing a set iron pipe at 216.00 feet; thence, N.30°00'41"E. a distance of 526.26 feet along said centerline to a point on the Southeast corner of M. & E. Ward (332/352); thence, N.76°12'00"W. a distance of 271.77 feet along said Ward lands to a set iron pipe, passing a set iron pipe at 30.00 feet; thence, N.08°57'00"W. a distance of 175.96 feet along said Ward lands to a point on the South line of M. Smitley (965/331), passing a set iron pipe at 169.96 feet; thence, N.89°00'00"W. a distance of 220.00 feet along the South line of said Smitley lands to the point of beginning.

The above described parcel contains 5.412 acres, more or less, and is subject to all legal easements and right of ways. North is based upon an assumed meridian. All set iron pins are 3/4" x 30" pipes with I.D. caps.




SURVEY PLAT FOR DOROTHA WOLLANGUR
