## DEED DESCRIPTION

Situated in the State of Chio, County of Muskingum, Township of Falls, T-1, R-8, being a part of O. & H. Coulter V 499 P 744 & part of V 559 P 765, being part of Quarter Township 4, and more particularly described as follows:

( TRACT 4 ) Beginning at an iron pin found at the Southwest Corner of Lot 13 of Dillon Falls Drive # 2 Plat Book 8, Page 49; thence South 87 Degrees 59 Minutes 11 Seconds West 254.40 feet to an iron pin set in the centerline of a 12.00 feet easement being the abandoned Columbus, Newark & Zanesville Electric Railway and the place of beginning, passing an iron pin set at 70.62 feet; thence along said centerline South 15 Degrees 02 Minutes 30 Seconds West 223.23 feet to a point in said centerline; thence along said centerline South 10 Degrees 13 Minutes 56 Seconds West 42.53 feet to a point in said centerline; thence leaving said centerline North 89 Degrees 01 Minutes 49 Seconds West 331.38 feet to the low water mark of the Licking River, passing iron pins found at 26.44 feet and 327.38 feet; thence along the low water mark of the Licking River the following 3 courses to points: North 38 Degrees 40 Minutes 17 Seconds East 146.27 feet; thence North 48 Degrees 44 Minutes 35 Seconds East 93.93 feet; thence North 47 Degrees 44 Minutes 48 Seconds East 104.32 feet; thence leaving said river North 87 Degrees 59 Minutes 11 Seconds East 157.70 feet to the place of beginning, passing an iron pin set at 50.00 feet, containing 1.46 acres, more or less, subject to all legal highways and easements.

Iron pins set are 5/8 inch rebar with plastic identification caps.
