



Peter Dinan (Reg. The bearing used in this description are based on the south line of Lot 28 having a bearing of south 63 degrees 14 minutes 00 seconds west as shown on the plat of Maryland Heights Part 2. The iron pins described as set are 5/8 inch diameter 30 inches long, solid reinforcing bars with plastic identification caps.





