## Description For Conveyance E. Scott McCollister

Situated in the State of Ohio, County of Muskingum, Township of Falls.

Being a part of the Third Quarter of Township 1, Range 7, bounded and described as follows:

Commencing at an iron pin at the most southerly corner of Lot 25 in Home-  
stead Hills Subdivision as recorded in Plat Book 8, Page 65 of the records of  
Muskingum County, Ohio; thence north 84 degrees 27 minutes west 191.13 feet to  
an iron pin; thence north 73 degrees 32 minutes west 63.29 feet to an iron pin  
and the true place of beginning of the premises herein intended to be described;  
thence south 5 degrees 02 minutes west 259.36 feet to an iron pin; thence north  
84 degrees 58 minutes west 552.57 feet to a point in the center of Dresden Road;  
thence along the center of said road north 10 degrees 11 minutes east 181.82  
feet to a point; thence leaving said road south 80 degrees 45 minutes east 226.50  
feet to an iron pin; thence north 3 degrees 51 minutes east 134 feet to an iron  
pin; thence south 86 degrees 09 minutes east 109 feet to an iron pin; thence  
south 73 degrees 32 minutes east 208.31 feet to the true place of beginning, con-  
taining two and ninety-eight hundredths (2.98) acres more or less.

Subject to the easements of Dresden Road.

There is also hereby conveyed to the Grantees herein an easement for  
ingress and egress over the following described parcel.

Beginning at the southwest corner of the above described 2.98 acre parcel  
in the center of Dresden Road; thence along the south line of said 2.98 acre  
parcel south 84 degrees 58 minutes east 135.18 feet to a point; thence south 62  
degrees 58 minutes west 169.07 feet to a point in Dresden Road; thence along  
said road north 10 degrees 11 minutes east 90.12 feet to the place of beginning.


