

Being a part of Quarter Township ^{3?} (2), Township 1, Range 7 bounded and described as follows:

Commencing at an iron pin at the southwest corner of Lot 19 of Upper Highland Subdivision as recorded in Plat Book 8, Page 1; thence North 81 degrees 30 minutes 14 seconds East 190.51 feet to a point on the East line of East Highland Drive; thence South 8 degrees 18 minutes 10 seconds East 178.28 feet along said East right of way line to an iron pin; thence South 59 degrees 08 minutes 46 seconds East 387.16 feet to an iron pin; thence South 59 degrees 12 minutes 00 seconds East 420.23 feet to an iron pin found; thence South 44 degrees 59 minutes 05 seconds East 369.34 feet to an iron pin found; thence South 35 degrees 45 minutes West 150.0 feet to an iron pin and the true place of beginning of the premises herein intended to be described; thence South 54 degrees 15 minutes East 311.16 feet to a point on the Westerly right of way line of what was formerly the Wheeling and Lake Erie Railroad; thence along said right of way line South 39 degrees 10 minutes 57 seconds West 150.27 feet to a point; thence North 54 degrees 15 minutes West 302.16 feet to an iron pin; thence North 35 degrees 45 minutes East 150.0 feet to the true place of beginning, containing one and six hundredths (1.06) acres more or less.



