## Legal Description 0.536 Acres All of Joseph W. Pattison Parcel: Deed Book 530, Page 692

Situated in the Township of Falls, County of Muskingum, State of Ohio, and being a part of Quarter Township 3, Township 1N, Range 7W, of the United States Military Lands, and being more particularly described as follows;

Being a Re-Survey of a 0.57 Acre parcel conveyed to Joseph W. Pattison, as recorded in Deed Book 530, Page 692, in the Muskingum County Deed Records, and being all of Auditor's P.P.N. 17-63-01-07-000, and further described as follows;

Commencing for reference at a ¾" o.d. iron pin found on the North Right of Way Line of Venture Lane marking the Southwest corner of Lot 19 of Upper Highland Subdivision, as recorded in Plat Book 8, Page 1, in the Muskingum County Plat Records;

Thence, N 81°30'14" E 190.52 feet with the South line of said Lot 19 and extending to the East Right of Way Line of East Highland Drive (50' Wide R/W);

Thence, S 08°18'10" E 178.28 feet with the East Right of Way Line of East Highland Drive, to an angle point;

Thence, S 59°08'46" E 387.16 feet leaving East Highland Drive to an angle point;

Thence, S 59°12'00" E 420.23 feet to the Northeast corner of an 8.71 Acre parcel conveyed to Howard W. Andrews & Sara E Norris, as recorded in Deed Book 2733, Page 941;

Thence, S 44°59'05" E 369.34 feet with the East line of said 8.71 Acre parcel conveyed to Andrews & Norris (D.B.2733,Pg.941), to a ¾" o.d. iron pipe found marking the Southeast corner thereof;

Thence, S 35°45'00" W 448.71 feet with the South line of said 8.71 Acre parcel conveyed to Andrew & Norris (D.B.2733,Pg.941), to a ¾" o.d. iron pipe found marking the Southwest corner of a 0.51 Acre parcel conveyed to Marcia A. Owen & John F. Gildow, as recorded in Deed Book 1590, Page 856, and being the **PRINCIPAL PLACE OF BEGINNING** of the **0.536 Acre parcel** herein to be described;

Thence, S 54°39'43" E 293.26 feet with the South line of said parcel conveyed to Owen & Gildow (D.B.1590,Pg.856), and extending across North Linden Avenue, to the West Right of Way Line of the Norfolk & Western Railroad, and passing over a ¾" o.d. iron pipe found at 288.10 feet;

Thence, S 41°37'48" W 90.70 feet with the West Right of Way Line of said Railroad, to a ¾" o.d. iron pipe found marking the Northeast corner of a 0.58 Acre parcel conveyed to Dustin R. Ziemer, as recorded in Deed Book 2753, Page 71, to a 5/8" o.d. iron pin found;

Thence, N 35°45'00" E 71.40 feet with the East line of said 8.71 Acre parcel conveyed to Andrews & Norris (D.B.2733,Pg.941), to the **PRINCIPAL PLACE OF BEGINNING**, and containing **0.536 Acres**, more or less, and is subject to all legal easements, right of ways, zoning restrictions, and ordinances of record.

The above described **0.536** Acre parcel contains **0.079** Acres in the Right of Way of North Linden Avenue, leaving a net area of **0.457** Acres, more or less.


