Being a part of Lot 4 and a strip off the southeast side of Lot 3 of Sunkel Brothers Subdivision as Recorded in Plat Book 5, Page 69 in Quarter Township Two (2), Township One (1), Range Seven (7) in the United States Military Lands and part of property now Recorded in the name of Robert L. Todd in Deed Book 1064, Page 333 of the Deed Records in said County bounded and described as follows:

Commencing at an iron pipe found at the southwest corner of Lot 4; thence N.30°12'14"E. (the base of bearings for this description true north by sun observation) along the west line of said Lot 4 a distance of 57.91' to an iron pin set at the true place of beginning for the following described parcel; thence continuing N.30°12'14"E. along the west line of said Lot 4 a distance of 85.00' to an iron pipe found at the northwest corner of Lot 4; thence S.59°52'01"E. along the north line of Lot 4 and the south line of Lot 3 a distance of 64.52' to an iron pipe found; thence crossing into Lot 3 S.62°32'09"E. 62.40' to an iron pipe found; thence S.59°37'59"E. 186.16' to an iron pin set on the west line of North Linden Avenue; thence along the west line of said road on a couve to the left having a radius of 2954.93' (the chord of which bears S.35°09'13"W. 2.99') an arc distance of 2.99' to a point at the southeast corner of said Lot 3 and the northeast corner of said Lot 4; thence continuing along the west side of said North Linden Avenue on a curve to the left having a radius of 2954.93' (the chord of which bears S.34°19'14"W. 82.01') an arc distance of 82.01' to an iron pin set; thence N.60°18'37"W. 306.88' to the true place of beginning containing sixty one hundredths (0.61) of an acre of which 0.015 of an acre is in Lot 3 and 0.595 of an acre is in Lot 4.

The above described parcel is part of Auditors Parcel No. 17-17-63-02-31.






BASE OF BEARINGS TRUE
