SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, TOWNSHIP OF FALLS, AND BEING PART OF QUARTER TOWNSHIP 4, TOWNSHIP 1, RANGE 8, AND ALSO BEING PART OF LOT #2 IN COLONEL JACKSON HEIGHTS, AS RECORDED IN PLAT BOOK 15, PAGE 11, AND BEING PART OF THOSE LANDS INTENDED TO BE DESCRIBED IN PARCEL #2 AND PARCEL #3 OF DEED VOLUME 957, PAGE 137; BEING FURTHER BOUNDED AND DESCRIBED AS FOLLOWS:

THENCE, NORTH 72 DEGREES - 03 MINUTES - 35 SECONDS WEST, 85.64 FEET TO A POINT;


