Deed Description of 1.005 acre parcel

Being a resurvey of a parcel conveyed to Erma V., James D., Gerald J., and Thomas F. Paul, as described and recorded in Official Record 1721, Page 810, as found in the Office of The Recorder, Muskingum County, Ohio, and being more particularly described as follows.

Situated in the State of Ohio, County of Muskingum, Township of Falls, being a part of Lots no. 8, 9, 10, and 11, in Fair Oaks Addition, in the Fourth Quarter, Twp. 1, Rng. 8, United States Military Lands, Plat Book 4, Page 84, and being more particularly described as follows.

COMMENCING, at an iron rebar found at the Southwest corner of Lot Number 8, N 04° 00' 00" E, a distance of 220.00 feet to an iron rebar found, said iron rebar also marks THE TRUE PLACE OF BEGINNING, for the parcel herein described.

Thence, from said iron rebar found, N 04° 00' 00" E, a distance of 50.00 feet to an iron rebar set.

Thence, from said iron rebar set, S 77° 16' 00" E, a distance of 313.80 feet to an iron rebar set on the West right of way line of Musselman Ave.

Thence, from said iron rebar set and following the right of way of Musselman Ave., S 03° 40' 00" W, a distance of 15.00 feet to an iron rebar set.

Thence, from said iron rebar set, and leaving the West right of way line of Musselman Ave., N 77° 35' 10" W, a distance of 115.92 feet to an iron rebar set.

Thence, from said iron rebar set, S 04° 00' 00" W, passing over an iron rebar found at 316.00 feet, a total distance of 346.00 feet to a point in the centerline of Newark Road (aka State Route 146).

Thence, from said point, and following the centerline of Newark Road (aka State Route 146), N 60° 53' 00" W, a distance of 116.00 feet to a point.

Thence, from said point, N 04° 00' 00" E, and leaving the centerline of Newark Road (aka State Route 146), passing an iron rebar found at 30.00 feet, a total distance of 250.00 feet to an iron rebar found.

Thence, from said iron rebar found, N 60° 53' 00" W, a distance of 100.00 feet to THE TRUE PLACE OF BEGINNING, for the parcel herein described.

Said parcel as surveyed contains 1.005 acres as surveyed.

Bearings of the above descriptions are based on the centerline of Newark Road (aka State Route 146) as being N 60° 53' 00" W, and are used to denote angles only.

Note: all Deed Volumes, Official Records, Instrument Numbers, and Pages referenced to above are found in the Office of the Recorder, Muskingum County, Ohio.

All iron pins set are 5/8" o.d. reinforcing bars 30" long with yellow caps labeled "John W. Hagan #4968".




