BEING A PART OF THE 179.00 MORE OR LESS ACRE TRACT CONVEYED TO OHIO UNIVERSITY BY DEED RECORDED IN VOLUME 538, PAGE 801 OF THE MUSKINGUM COUNTY DEED RECORDS, SITUATED IN QUARTER TOWNSHIP 4, TOWNSHIP 1, RANGE 8, OF THE UNITED STATES MILITARY LANDS, FALLS TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

COMMENCING AT AN EXISTING IRON PIN (1 1/4 INCH PIPE) AT THE SOUTHWEST CORNER OF LOT 6B OF ADAMS SUBDIVISION AS RECORDED IN PLAT BOOK 4, PAGE 134 OF THE MUSKINGUM COUNTY PLAT RECORDS; THENCE NORTH 05 DEGREES 08 MINUTES 37 SECONDS EAST 640.65 FEET ALONG THE WESTERLY LINE OF LOT 6B AND LOT 7B (THE SOUTH LINE OF AMERICAN ROLLING MILL COMPANY) TO AN EXISTING IRON PIN (5/8 INCH REBAR), PASSING AN EXISTING IRON PIN (5/8 INCH REBAR) AT 526.62 FEET; THENCE NORTH 86 DEGREES 12 MINUTES 51 SECONDS WEST 130.02 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR) ON THE EASTERN LINE OF THE ABOVE MENTIONED OHIO UNIVERSITY TRACT, SAID IRON PIN BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED; THENCE WITH THE SAID EASTERN LINE OF OHIO UNIVERSITY SOUTH 05 DEGREES 10 MINUTES 24 SECONDS WEST 108.49 FEET TO AN IRON PIN SET, SAID IRON PIN BEING NORTH 05 DEGREES 10 MINUTES 24 SECONDS EAST 2.56 FEET FROM AN EXISTING IRON PIN (5/8 INCH REBAR); THENCE NORTH 84 DEGREES 54 MINUTES 05 SECONDS WEST 90.00 FEET TO AN IRON PIN SET; THENCE NORTH 05 DEGREES 11 MINUTES 15 SECONDS EAST 106.43 FEET TO AN IRON PIN SET ON THE SOUTH LINE OF SAID ARMO TRACT, SAID IRON PIN BEING SOUTH 86 DEGREES 12 MINUTES 51 SECONDS EAST 321.09 FEET FROM AN EXISTING IRON PIN (3/4 INCH PIPE) AT THE SOUTH WESTERN MOST CORNER OF SAID MILL COMPANY; THENCE SOUTH 86 DEGREES 12 MINUTES 51 SECONDS EAST 90.00 FEET ALONG THE SAID MILL CO. TRACT TO THE PLACE OF BEGINNING.




