Situated in the State of Ohio, County of Muskingum, Township of Falls, Part of Lots 1-B and 2-B of Adams Subdivision (PB 4, Pg. 134) and being all of the lands now owned by Marlene Moore as recorded in OR 2023-378 of the Muskingum County Recorders Office and more particularly described as follows.

Beginning at an iron pin set at the northwest corner of Lot 2-B, thence with the north line of said lot and the corporation line for the City of Zanesville, S 74°25'00" E a distance of 150.76 feet to an iron pin found on the northwest corner of the lands now owned by Ronald E. Ervin & Marie L. Ervin (DR 1115-480);

thence leaving said north line and going with the common line of said Moore/Ervin's lands, S 23°37'43" W a distance of 227.29 feet to a point on the southeast corner of said Moore's lands on the north line of Doaks Lane, passing an iron pin found at 117.09 feet, said point is referenced by an iron pin found that bears S 03°32'04" E a distance of 1.10 feet;

thence with the north line of said Doaks Lane, N 66°22'43" W a distance of 76.27 feet to an iron pin found at the southwest corner of said Moore's lands, also being on the corporation line of said City of Zanesville;

thence with said corporation line, N 04°07'56" E a distance of 218.75 feet to the place of beginning, passing in iron pin set at 108.75 feet, containing 0.570 acres more or less, subject to all legal highways and easements of record.

All bearings described herein are based on the Ohio State Plane Grid Coordinates, NAD83, Ohio South per GPS Observation.

All iron pins set are 5/8 inch by 30 inch steel rebar with plastic identification caps marked MCPEEK PS8517.
