
PARCEL ONE:

Situated in the State of Ohio, County of Muskingum, Township of Falls.

Being a part of Quarter Township 4, Township 1, Range 8 bounded and described as follows:

Commencing at the intersection of the west line of the County Infirmary Farm and the center of State Route #146, which point is also the northeast corner of Locust Springs Subdivision as recorded in Plat Book 7, Page 59; thence along the center of State Route #146 north 65 degrees 17 minutes 32 seconds west 2617.46 feet to the true place of beginning of the premises herein intended to be described; thence south 11 degrees 32 minutes 18 seconds west 819.19 feet to an iron pin on the northerly line of the old abandoned Columbus, Newark and Zanesville Electric Railroad; thence along said line on a curve to the right having a radius of 1661.89 feet an arc length of 69.09 feet (the chord of which bears south 29 degrees 35 minutes 55 seconds east 69.08 feet) to an iron pin; thence continuing along said line south 28 degrees 24 minutes 27 seconds east 474.10 feet to a point in the center of the Licking River; thence along the center of said river south 73 degrees 34 minutes 40 seconds west 132.90 feet to a point; thence leaving said centerline north 28 degrees 24 minutes 27 seconds west 70.0 feet to a point on the north bank of said Licking River; thence along the north bank of said river the following (4) courses and distances, south 73 degrees 34 minutes 40 seconds west 54.19 feet to a point; thence south 76 degrees 27 minutes 22 seconds west 230.97 feet to a point; thence north 63 degrees 43 minutes 26 seconds west 195.45 feet to a point; thence north 41 degrees 27 minutes 32 seconds west 102.39 feet to a point; thence leaving said river bank north 3 degrees 55 minutes 49 seconds east 814.81 feet to an iron pin on the northerly right of way of the aforesaid railroad; thence along said right of way south 41 degrees 50 minutes 27 seconds east 262.78 feet to an iron pin; thence continuing along said right of way on a curve to the right having a radius of 1661.89 feet an arc length of 193.64 feet (the chord of which bears south 38 degrees 30 minutes 10 seconds east 193.53 feet) to an iron pin; thence north 11 degrees 00 minutes 36 seconds east 755.17 feet to a point in the center of State Route #146; thence along the center of said road south 63 degrees 03 minutes 34 seconds east 99.49 feet to the true place of beginning, containing nine and eighty hundredths (9.80)



