Situated in the State of Ohio, County of Muskingum, Township of Falls and bounded and described as follows:

Being a part of lands now owned by City of Zanesville (DR 1093-337) and being more particularly bounded and described as follows:

Beginning for reference at an iron pipe found on the northeast corner of Lot 3 of Edmund Brush Subdivision as designated and delineated on Muskingum County Plat Book 1, Page 208; thence along the east line of lands now owned by Sarel Offinger (DR 1101-113) the following four courses:

- 1) South 09 degrees 48 minutes 01 seconds East for a distance of 242.17 feet to an iron pin found;
- 2) South 14 degrees 43 minutes 42 seconds East for a distance of 194.32 feet to an iron pipe found;
- 3) South 08 degrees 58 minutes 08 seconds East for a distance of 144.55 feet to an axle found on the northwest corner of lands now owned by G. Benton (OR 1599-20);
- 4) thence along said G. Benton's west line South 08 degrees 54 minutes 15 seconds East for a distance of 7.39 feet to a point on the northeast corner of lands now owned by Beitzel Family Limited Partnership (DR 1125-794);

thence along said Beitzel Family Limited Partnership's north line South 81 degrees 25 minutes 38 seconds West for a distance of 264.20 feet to an iron pin to be set after construction on the east line of lands now owned by City of Zanesville (DR 1093-337), passing an iron pin to be set after construction at 157.64 feet;

thence along said City of Zanesville's east line North 28 degrees 38 minutes 22 seconds West for a distance of 66.32 feet to an iron pin to be set after construction and the principal place of beginning;

thence through said City of Zanesville's lands North 28 degrees 38 minutes 22 seconds West for a distance of 42.67 feet to an iron pin to be set after construction on said Offinger's west line;


thence along said Offinger's west line South 41 degrees 08 minutes 51 seconds East for a distance of 41.66 feet to an iron pin to be set after construction at the northeast corner of said City of Zanesville's lands;

thence along said City of Zanesville's lands South 48 degrees 51 minutes 09 seconds West for a distance of 9.24 feet to the principal place of beginning;

containing 192 square feet, more or less, subject to all legal road right of ways and applicable easements, written or implied.


