

GENERAL NOTES

- 1. SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, TOWNSHIP OF FALL, BEING PART OF THE FORTH QUARTER(4), OF TOWNSHIP ONE(1), RANGE EIGHT(6), UNITED STATES MILITARY LAND.
- 2 BY SCALED MAP LOCATION AND GRAPHIC PLOTTING ONLY, THE SUBJECT PROPERTY (PARCEL 'A') APPEARS TO LIE ENTIRELY IN ZONE X UNSHADED (AREAS DETERMINED TO BE OUTSIDE THE 0.2% ANNUAL CHANCE FLOODPLAIN) ACCORDING TO THE FLOOD INSURANCE RATE MAP FOR MUSKINGUM COUNTY UNINCORPORATED AREAS, COMMUNITY PANEL NO. 39119C0285G, EFFECTIVE DATE JULY 6, 2010.
- 3. THE BASIS OF BEARING, DERIVED FROM ODOT VRS NETWORK, OHIO SOUTH NAVD88(2011), BEING THE CENTERLINE OF NEWARK ROAD (S.R.146), IS SOUTH 40° 56' 08" EAST.
- 4. THE CURRENT OCCUPANTS OF THE BUILDING WERE UNABLE TO CONFIRM NOR DENY THE USE OF THE SEPTIC SYSTEM OBSERVED ON THE PROPERTY OR THE LOCATION OF SANITARY LINES BEING USED. THE CURRENT OCCUPANTS STATED THAT THEY THOUGHT THERE WAS NO WELL AND THAT THEY WERE ON CITY WATER. NO WATER WELL WAS OBSERVED AT THE TIME OF SURVEY.
- 5. THE ZONING OF PARCEL 'A' TO CHANGE FROM INDUSTRIAL ZONE TO COMMERCIAL ZONE WAS APPROVED BY THE FALLS TOWNSHIP TRUSTEES JANUARY 13, 2022.
- 6. THE RESIDUAL ACREAGE OF 17-79-02-10-000 WILL NOT BE CONVEYED AS A SEPARATE BUILDING SITE OR INDEPENDENT PARCEL UNLESS PROPER APPROVALS ARE RECEIVED FROM MUSKINGUM COUNTY PLANNING COMMISSION.

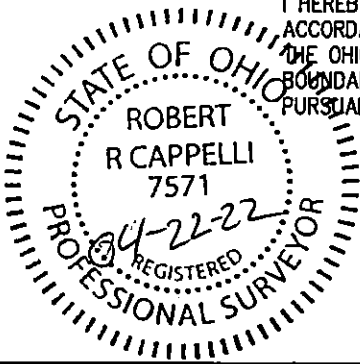
STRUCTURE w/ CLOSEST DISTANCE
