

Situated in the State of Ohio, County of Muskingum, Township of Falls.

Being a part of Quarter Township 3, Township 1, Range 8 bounded and described as follows:

Commencing at the Northwest corner of Lot 9 in Monroe and Duncans Sub-division; thence south 190.0 feet to a stone; thence north 89 degrees 52 minutes 04 seconds west 1650.04 feet to an iron pin; thence north 0 degrees 07 minutes 56 seconds east 1035.64 feet to an iron pin and the true place of beginning of the premises herein intended to be described; thence north 0 degrees 07 minutes 56 seconds east 180.41 feet to an iron pin; thence north 25 degrees 45 minutes 03 seconds east 53.08 feet to an iron pin; thence south 89 degrees 52 minutes 04 seconds east 255.35 feet to an iron pin; thence north 0 degrees 07 minutes 56 seconds east 40.70 feet to an iron pin; thence south 89 degrees 52 minutes 04 seconds east 459.22 feet to an iron pin; thence south 8 degrees 33 minutes 48 seconds east 210.72 feet to an iron pin; thence north 61 degrees 15 minutes 08 seconds east 147.18 feet to an iron pin; thence south 0 degrees 23 minutes 07 seconds west 406.76 feet to a 20 inch tree at the corner; thence north 57 degrees 22 minutes 46 seconds west 100.17 feet to an iron pin; thence north 69 degrees 18 minutes 38 seconds west 171.51 feet to an iron pin; thence north 75 degrees 59 minutes 12 seconds west 670.96 feet to the true place of beginning, containing seven and eight hundredths (7.08) acres more or less.


