PART OF AUDITORS PARCELS

17-82-02-02-000 (5.86 Acres)

17-82-02-03-000 (0.74 Acres)

Situated in lots 8 and 9 of Monroe Duncan Subdivision, Quarter township 3, T-1-N, R-8-W, U.S.M.L., Falls Township, Muskingum County, Ohio.

Commencing at an iron pin marking the Northwest corner of lot 8 of Monroe Duncan Subdivision; Thence, S.01°41'46"W. a distance of 534.61 feet along the West line of said to a point on the South line of the lands of M. & T. Young (1078/518), and BEING THE POINT OF BEGINNING;

Thence, **N.71°03'20"E.** a distance of **44.57 feet** along said Young lands to a found iron pin;

Thence, **N.59°53'47"E.** a distance of **441.21 feet** along said Young lands to a found iron pin;

Thence, **N.77°40'03"E.** a distance of **547.23 feet** along the South lines of the lands, now or formerly, owned by W. Adams, IV, (1129/681 & 1536/11) to a point in the center of Jersey Ridge Road passing found iron pins at 319.52 and 527.22 feet;

Thence, **S.18°20'43"E.** a distance of **14.80 feet** along said road to a point;

Thence, **S.08°40'56"E.** a distance of **78.69 feet** along said road to a point;

Thence, **S.04°59'52"W.** a distance of **59.69 feet** along said road to a point;

Thence, **S.77°45'01"W.** a distance of **581.12 feet** along the north line of the lands, now or formerly, owned by M. Harlow (1145/161) to a found iron pin, passing a found iron pin at 15.00 feet;

Thence, **S.07°55'36"W.** a distance of **395.29 feet** along the west line of the lands, now or formerly, owned by W. Adams, III (1134/275) to a found iron pin;

Thence, **S.78°12'19"W.** a distance of **272.12 feet** through the lands of M & T. Young (1120/503) to a set rebar;

Thence, **N.46°40'50"W.** a distance of **424.13 feet** through said Young lands to a set rebar on the south line of the lands of M. & T. Young (1078/518);

Thence, **N.71°03'20"E.** a distance of **240.59 feet** along said Young lands to the point of beginning.

The above described parcel contains **6.60 Acres**, more or less, (5.86 acre in lot 8 and 0.74 acres in lot 9) subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.

Also attached to the above described parcel is a 50 foot wide right of to Jersey Ridge road and being described as follows:

Beginning at the Southeast corner of the above described 6.60 acre parcel, also being the Southwest corner of the lands, now or formerly, owned by W. Adams, III (1134/275);

Thence, **N.78°14'24"E.** a distance of **699.94 feet** along the south line of said Adams lands to a point in the center of Jersey Ridge Road; Thence, **S.39°26'09"E.** a distance of **19.42 feet** along said road to a point; Thence, **S.43°31'09"E.** a distance of **38.06 feet** along said road to a point; Thence, **S.78°12'19"W.** a distance of **966.22 feet** through the lands of M. & T. Young (1120/503) to a point; Thence, **N.46°40'50"W.** a distance of **60.96 feet** through said Young lands to a set rebar on the Southwest corner of the above described 6.60 acre parcel; Thence, **N.78°12'19"E.** a distance of **272.12 feet** along the south line of said parcel to the point of beginning.

The above described right of way covers 1.11 acres.


