COMMENCING AT THE NORTHWEST CORNER OF LOT NUMBER 1 OF MONROE AND DUNCAN'S SUBDIVISION; THENCE SOUTH 88 DEGREES 11 MINUTES 12 SECONDS EAST 220.88 FEET ALONG THE NORTH LINE OF LOT NUMBER 1 TO A POINT MARKED BY AN EXISTING IRON PIN (BOLT) ON THE WEST SIDE OF COUNTY ROAD NUMBER 296 (JERSEY RIDGE ROAD); THENCE SOUTH 08 DEGREES 54 MINUTES 28 SECONDS EAST 101.49 FEET TO A POINT MARKED BY A METAL FENCE POST ON THE SAID WEST SIDE OF COUNTY ROAD NUMBER 296; THENCE SOUTH 10 DEGREES 00 MINUTES 19 SECONDS EAST 174.85 FEET TO A POINT MARKED BY AN EXISTING IRON PIN (5/8 INCH REBAR) ON THE SAID WEST SIDE OF COUNTY ROAD NUMBER 296; THENCE SOUTH 26 DEGREES 23 MINUTES 03 SECONDS EAST 230.03 FEET TO A POINT MARKED BY AN IRON PIN SET (5/8 INCH REBAR), SAID POINT BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED; THENCE SOUTH 88 DEGREES 20 MINUTES 16 SECONDS EAST 19.92 FEET TO A POINT IN THE CENTER OF SAID COUNTY ROAD NUMBER 296; THENCE SOUTH 28 DEGREES 25 MINUTES 47 SECONDS EAST 201.86 FEET ALONG THE WEST LINE OF PARCEL NUMBER 2 AND PARCEL NUMBER 3 CONVEYED TO K.
