Commencing at a concrete monument* on the line between lots 237 and 236; Thence North 69 29'00" East 107.80 feet to a point on the Northerly line of Licking Road; Thence along Licking Road and R&E Wright North 35 26'46" West 413.97 to an Axle Found; Thence across said road South 69 29'00" West 30.00 feet to a point, the Place of Beginning; Thence South 35 26'46" East along Licking Road 150.00 feet to a point; Thence Leaving Licking Road and along split line of Phyllis Hammer Vol. 598, page 75 South 69 29'00" West 178.91 feet to an iron pin set on the Northerly line of Old abandoned B&O Rail Road, passing an iron pin at 5.00 feet; Thence along abandoned B&O Rail Road North 36 52'00" West 151.05 feet to an iron pin set on the Westerly line of of lot 238; Thence along said lot line North 69 29'00" East 182.79 to the Place of Beginning.


