Commencing at an iron pin found at the northwest corner of Lot 5 in Hills and Dales Subdivision as recorded in Plat Book 7, Page 5-A; thence along the north line of Lot 5 north 71 degrees 21 minutes east 29.97 feet to a point; thence along the west line of property conveyed to Paul W. Debolt by deeds recorded in Deed Book 1060, Page 439 and Deed Book 1113, Page 367 north 4 degrees 11 minutes west 530.43 feet to a point in the center of the Old National Road; thence along the center of said road north 85 degrees 52 minutes east 78.08 feet to a point; thence continuing along said centerline north 86 degrees 13 minutes east 55.94 feet to the true place of beginning of the premises herein intended to be described; thence continuing along the center of said road north 86 degrees 13 minutes east 96.16 feet to a point; thence leaving said road south 5 degrees 28 minutes east 311.86 feet to a point; thence north 85 degrees 33 minutes west 109.70 feet to a point; thence north 3 degrees 09 minutes west 296.03 feet to the true place of beginning. 
