

Commencing at an iron pin found at the southeast corner of Lot 8 in Shagbark Woods Subdivision as recorded in Plat Book 15, Pages 139 and 140; thence north 4 degrees 58 minutes 29 seconds east 166.91 feet to an iron pin; thence north 63 degrees 37 minutes 29 seconds east 370.68 feet to an iron pin; thence north 5 degrees 55 minutes east 249.34 feet to an iron pin and the true place of beginning of the premises herein intended to be described; thence south 86 degrees 58 minutes west 200.97 feet to an iron pin; thence north 3 degrees 02 minutes west 12 feet to an iron pin at the southwest corner of a 2.64 acre parcel conveyed to Steve Carter by Deed recorded in Deed Book 724, Page 179; thence along the south line of said 2.64 acre parcel north 86 degrees 58 minutes east 202.86 feet to an iron pin; thence south 5 degrees 55 minutes west 12.15 feet to the true place of beginning, containing six hundredths (0.06) of an acre more or less.


