Situated in the State of Ohio, County of Muskingum, Township of Falls, bounded and described as follows:

Being a part of Quarter Township 3, T-1, R-8, of the United States Military Lands and being part of the lands now owned by Leoma Quinn as the same is recorded in Muskingum County Deed Record 964-120, Exhibit "A", and being more particularly described as follows:

Beginning for reference at the Northeast corner of Lot 44 of Westwood Hills Subdivision as the same is designated and delineated in Muskingum County Plat Book 13, Page 19 and now owned by Ohio Rural Water Association (OR 1902-754);

thence along the north line of said Lot 44, South 78 degrees 16 minutes 57 seconds West 20.00 feet to an iron pin found on the west right of way of Whites Road (TR-144) and the southeast corner of Lot 6 of Hills and Dales Estates as the same is designated and delineated on Muskingum County Plat Book 7, Page 5, and being the principal place of beginning;

thence continuing along said north line of said Lot 44 and Lot 7 of said Westwood Hills Subdivision, South 78 degrees 16 minutes 57 seconds West 663.66 feet to a point on the east line of Lot 76 of said Westwood Hills Subdivision, passing an iron pin found at 628.83 feet;

thence along the east line of Lots 75 and 76, now owned by Hupp-Wilbert Vault Co., Inc. (DR 616-121), North 27 degrees 23 minutes 59 seconds West 195.60 feet to an iron pin found on the southwest corner of lands now owned by James N. Debolt (OR 2298-456) and the north line of said Lot 5, North 68 degrees 49 minutes 47 seconds East 278.55 feet to an iron pin found on the west line of lands now owned by S. & L. Blumenstock, LLC (OR 2350-174, Parcel One), from which an iron pin found bears North 08 degrees 02 minutes 21 seconds West 1.25 feet;


