Commencing at an iron pin at the northeast corner of Lot 15 in Wildwood Subdivision as Recorded in Plat Book 13, Page 41; thence crossing Ivy Drive south 44 degrees 03 minutes east 50 feet to an iron pin; thence along the easterly side of Ivy Drive on a curve to the left having a radius of 410.05 feet an arc distance of 66.07 feet (the chord of which bears north 41 degrees 20 minutes east 66 feet) to an iron pin and the true place of beginning of the premises herein intended to be described; thence continuing along said Ivy Drive on said curve to the left having a radius of 410.05 feet an arc distance of 67.07 feet (the chord of which bears north 31 degrees 45 minutes east 67.0 feet) to an iron pin; thence south 63 degrees 47 minutes 41 seconds east 49.21 feet to an iron pin; thence south 26 degrees 37 minutes 48 seconds east 95 feet to an iron pin; thence north 45 degrees 25 minutes east 10 feet to an iron pin; thence south 26 degrees 36 minutes east 157.93 feet to an iron pin; thence south 40 degrees 54 minutes 25 seconds west 741.40 feet to an iron pin; thence north 31 degrees 58 minutes west 422.10 feet to an iron pin; thence north 77 degrees 09 minutes 28 seconds east 312.22 feet to an iron pin; thence north 66 degrees 12 minutes 09 seconds east 177.55 feet to an iron pin; thence north 20 degrees 19 minutes 15 seconds east 243.28 feet to an iron pin; thence north 68 degrees 06 minutes 06 seconds west 45.48 feet to the true place of beginning, containing four and nineteen hundredths (4.19) acres more or less.


